

WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, April 18, 2022 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Matthew Mize, Lorissa Sweet, Matt Dillon, Philip Dale and Sam Hann. Barbara Pearson was present via Zoom. Mize opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the March 21, 2022 meeting. Dillon made a motion to approve the minutes as presented. Dale seconded the motion and it passed by a 7-0 roll call vote.

County Tax Abatements:

Alan Marquardt of Custom Cartons Inc. presented his request via Zoom for tax abatement. Marquardt said they are working on meeting the expectation of the abatement. Custom Cartons is currently looking for 4 to 5 more employees. Marquardt will stop into the auditor's office to sign his CF-1 before the due date of May 15, 2022. Dale made a motion to approve the tax abatement once it is completed. Dillon seconded the motion; it passed by a 7-0 roll call vote.

Bob Hettmansperger of Advanced Ag Resources presented his request for tax abatement. Hettmansperger said he did not have his CF-1 but his attorney was working on it and would e-mail the paperwork to Shepherd. Dillon made a motion for conditional approval of the tax abatement pending the CF-1 being received and signed by the May 15, 2022 deadline. Sweet seconded the vote; it passed by a 7-0 roll call vote.

Sam Krouse of Midwest Poultry Services presented his request for tax abatements. MPS has submitted the correct paperwork and met all expectations of the abatement. Dale made a motion to approve both real and personal property tax abatements for MPS. Dillon seconded the motion; it passed by a 7-0 roll call vote.

Donna Huneryager and Rick Fisher for Vision Properties LLP & Lens Source Optical Laboratory presented a request for tax abatements. Huneryager did not have the CF-1 for the personal property request as she was mistaken on who to send it to. Huneryager said she would e-mail the CF-1 for personal property to the auditor in the next couple days. Fisher reported they are meeting the expectations for the tax abatement and are employing close to 160 people at the lab. Dillon made a motion to approve both tax abatements if the CF-1 is completed and received before the May 15, 2022 deadline. Dale seconded the motion; it passed by a 7-0 roll call vote.

Next on the agenda were the requests for additional appropriations.


