

WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, February 20, 2023 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Matthew Mize, Barbara Pearson, Matt Dillon, Nick Kopkey, Sam Hann and Philip Dale. Pearson opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

First order of business was a review and approval of the minutes of the January 17, 2023 meeting. Mize made a motion to approve the minutes as presented. Dale seconded the motion; it passed by a 5-0-2 with Pearson and Dillon abstaining.

Mike Keaffaber and Danielle Gargiulo with the Wabash County Drug Prevention Steering Committee gave a presentation on the services they offer. Keaffaber informed the council that while it is challenging to ask organizations year after year for donations, many of the committee members and others in the community have worked diligently to raise funding for programs provided. The main focus will be on the K-12 students in Wabash County (prevention). Last summer was the largest community event, when the committee raised approximately \$18,000. Keaffaber explained they are still short for the program this year and need additional funds to plan for future years' programs. The Wabash County Drug Prevention Committee is asking for funding from the Opioid Settlement for the schools' programs. Bowman requested they put their requests in writing and submit them to Council.

Danielle Gargiulo for the Bowen Center requested matching funds for a grant that is due to be submitted on 02/27/2023 which is in connection with the States part of the Opioid Funds. The grant would fund a program with the jail for mental health services to be provided in the jail. Gargiulo requested \$75,000 for the two-year program. After discussion, Dale made a motion to match \$12,000 a year for the first two years with the money coming from the Opioid settlement. Pearson seconded the motion; it passed by a 7-0 vote.

Dan Gray, Wabash County Tobacco Free Coalition, said they have the Aaction grant process going again and will award \$40,000 a year. Gray said that the committee would be happy to allocate the funds on behalf of the Council from the opioid settlement, as this way the funds can be used on a broader scale. Bowman asked that he submit a request in writing.

Terry Burnworth, owners' rep for the Jail project, gave an update on the progress of the new jail. In the general overview, Burnworth said the project is 75% complete based on billing and the building is 90% enclosed. They are currently looking into fixing the roof leak problem. Burnworth estimates the job to be complete in August, with a September move-in date.

Next on the agenda were the requests for additional appropriations.
