WABASH COUNTY COUNCIL

The Wabash County Council met in session on Thursday, August 22, 2024 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 5:00 P.M. Council members present: Bowman, Matthew Mize, , Matt Dillon, Sam Hann, Philip Dale, and Gary Ridenour. Nick Kopkey arrived for the Budget Hearings. Bowman opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

<u>Tuesday</u>, <u>August 13 and Wednesday</u>, <u>August 14, 2024</u> - Full council was present for the Budget Hearings on Tuesday and Wednesday. The 2025 proposed budgets were presented by the elected officials and department directors. The council recommended changes to the budgets.

Thursday, August 22, 2024 5:00pm Wabash County Council Meeting First order of business was a review and approval of the minutes from the July 15, 2024 meeting. Dale made a motion to approve the minutes as presented. Ridenour seconded the motion; it passed by a 4-0-2-1 Dillon, Hann abstained, Kopkey absent.

Chairman Kyle Bowman presented to the Wabash County Council, read in full and adopted on the 22nd day of August 2024, a review of the estimated property tax levy limits and estimated reductions due to circuit breakers for each taxing district. Auditor Shepherd distributed copies of the 2025 Estimated Property Tax Caps Impact report and the 2025 Estimated Maximum Levy Reports to the Council for review and/or recommendation. She also submitted a comparison of 2025 levies and tax caps to last year.

Chairman Bowman then reopened the Budget Hearings, Council reviewed the budgets and made changes. Hann made a motion to approve the budget with the changes. Dillon seconded the motion; it passed by a 7-0 vote.

Bowman directed the Auditor's office to make the Council changes to the 2025 proposed budgets and prepare Budget Form 4, the ordinance and Form 4b that includes the tax levy and tax rates for official approval at the final adoption hearing advertised and scheduled for Monday, September 16, 2024.

With no other business to come before the Council for budgets, Kopkey made a motion to adjourn the budget hearings.
