

**WABASH COUNTY COUNCIL MEETING AND
FINAL ADOPTION HEARING OF THE 2018 BUDGETS AND
THE LOCAL INCOME TAX CREDIT RATES PUBLIC HEARING**

The Wabash County Council met in session on Monday, September 25, 2017 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Jeff Dawes called the meeting to order at 5:00 P.M. Seven Council members were present: Dawes, Randy Curless, Matthew Mize, Lorissa Sweet, Matt Dillon, Philip Dale, and Kyle Bowman. Bowman opened with a word of prayer and Dawes led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Dawes requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the August 28, 2017 Council meeting. Dillon made a motion to approve the minutes. Dale seconded the motion and it passed by a 6-0 vote with one abstention from Curless since he had been absent from that meeting. Next was the approval of the September 12, 13, 14 budget hearing minutes. Dillon made a motion to approve the minutes. Dale seconded the motion and it passed by a 7-0 vote.

The next order of business was to address a Transfer of Funds from one fund to another fund as allowed by IC 36-2-7-5.11(c). Present for the request was County Recorder Lori Draper.

**TRANSFER RESOLUTION

Whereas, it has been determined that it is now necessary to transfer money from one fund to another fund per IC 36-2-7-5.11(c); NOW, THEREFORE:

SEC. 1 Be it ordained by the Wabash County Council of Wabash County Indiana, that for the expense of said county government and its institutions for the year ending December 31, 2017, the following sums of money are hereby transferred and ordered set apart out of the two funds herein named and for the purposes herein specified, subject to the laws governing the same:

Explanation: Submitted by County Recorder, L. Draper: Per I.C 36-2-7.5-11(c): Money in the Security Protection Fund may be transferred to the County Recorder's Perpetuation Fund for the uses set forth in IC 36-2-7-10(f). IC 36-2-7.5-11(d): A county recorder may use money in the fund only to purchase, upgrade, implement, or maintain redacting technology, or to secure protection measures used in the office of the county recorder. The transferred money will be used toward the purchase of microfilm printer/reader.

Dillon made a motion to approve the request for a transfer of funds from one fund to another fund as allowed by IC 36-2-7.5-11(c). Curless seconded the motion and it passed by a 7-0 vote.

County Recorder Lori Draper requested to purchase a microfilm printer/reader, and to pay installation costs in the amount of \$12,000; using \$6,000 of the transferred funds from the Security Protection Fund and \$6,000 from the cash balance of the Recorder's Records Perpetuation Fund. Per IC 36-2-7-10(f), money from these funds can be used **without appropriation** as long as the money is spent for the preservation of records and/or the improvement of record keeping systems and equipment. Draper requested Council's approval of the purchase even though not required by statute for Council's information and as a courtesy. Dale made a motion to approve the purchase as requested. Sweet seconded the motion and it passed by a 7-0 vote.

WABASH COUNTY SOLID WASTE MANAGEMENT DISTRICT'S 2018 BUDGET HEARING

County Council Chairman Dawes opened the hearing of the Wabash County Solid Waste District's proposed 2018 budget for discussion and public input. Present for the hearing were Solid Waste Director, Jen Rankin and Solid Waste Board member, Ken Ahlfeld. County Council had reviewed the 2018 proposed budget of the Solid Waste District at the September 14, 2017 county budget hearing. Council had noted that the Solid Waste budget included larger increases for two Solid Waste employee positions than the 1% increase preliminarily approved for county employees. At the time, Commissioner Hauptert had reported that the Solid Waste District needs to attract better qualified employees who are interested in employment longevity with the Solid Waste District. Rankin and Ahlfeld explained that the cost of materials has increased substantially which results in a larger increase in that budget account. The Council suggested no decreases, increases or changes to the budget as proposed. No public comment was heard. The final adoption hearing is scheduled for October 23, 2017.

FINAL ADOPTION HEARING OF THE 2018 WABASH COUNTY BUDGETS

Councilman Dawes thanked the County departments for their cooperation and thanked the County Auditor's office for the assistance that Council received

during the 2018 budget process. Council's consensus was to approve the budgets as previously modified at the Sept. 14th budget hearing with salary increases as designated, decreases to the proposed budgets as designated, and the transfer of certain expenses as designated. The General Fund budget also includes the \$113,998 in property tax caps. Upon approval by Council, the estimated property tax levy will be approximately \$104,606 over the maximum levy allowed, but the levy and tax rates will be officially determined by the Department of Local Government Finance (DLGF) after submission of the budgets and tax levies by the Auditor's office. The DLGF must certify the 2018 budget before, or by February 15, 2018.

Dale made a motion to approve **Ordinance #2017-85-05 for 2018 Appropriations and Tax Rates which adopts the General Fund Budget, the Tax-rated Fund Budgets and all Wabash County Special Revenue (home-ruled) Budgets.** Mize seconded the motion and it passed by a 6-1 vote with Dillon voting against the adoption of the budget. LOCAL INCOME TAX (LIT) CREDIT RATES PUBLIC HEARING

Chairman Dawes called to order the advertised public hearing for the purpose of discussion and public input for review and/or the possible rearrangement of percentages of the Wabash County local income percentage rates within the current total of local income tax rates of 2.90%.

While waiting for the arrival of Tax Consultant, Darren Bates, Auditor Shepherd explained to Council about an income tax option that would fund the

approximate \$600,000 budget of the County's Central Dispatch department that is currently being funded from the County's General Fund. She had been informed by Mr. Bates and the Department of Local Government Finance (DLGF) of the **Public Safety Access Point (PSAP)** income tax option that would fund the expenses of a central dispatching call center with the exception of a building purchase and/or building maintenance, as defined by the state statute governing the income tax option. The option for Wabash County would include the rearrangement of percentages recommendation from Mr. Bates for a decrease in the property tax relief percentage from 1.00% to .50% and an increase in certified shares or tax revenue from the current 1.40% to 1.90%. The PSAP option would further rearrange the percentages to fund the PSAP at .09% and a .41% increase (instead of a .50% increase) in certified shares/revenue, with similar results for the relief of the General Fund's expenses since the Central Dispatch departmental budget is currently within the General Fund. Darren Bates, Tax Data Consultant, now present for the public hearing further elaborated on the PSAP option presented by Auditor Shepherd. He stated that the PSAP income tax option benefits only the county taxing unit and no other local taxing units, because the county has the burden of funding central dispatching services. He stated that with approval of this option, there would be less property tax caps and a lower property tax rate because of decreasing the expense of the General Fund. Auditor Shepherd suggested that a full year of distribution should be deposited into a PSAP Fund before being budgeted. Since the PSAP option needs to be advertised for a public hearing, Chairman Dawes polled the Council to determine if there is sufficient interest to pursue the option before advertising a hearing for next month. All Council members except Councilman Dillon were in favor of advertising a public hearing to consider the PSAP option. Auditor Shepherd will advertise the public hearing for Monday, October 16, 2017 at 5:00 P.M.

Bates stated that the purpose for the rearrangement of credit percentages is an attempt to prevent property and income taxes from increasing. Bates stated that with the new laws governing LIT, the percentages can be reviewed and/or changed each year if Council chooses to do so. He again explained his previous recommendation from the August 28, 2017 Council meeting for a 3-5 year plan to increase revenue within the first year of the plan by the re-arrangement of percentages by increasing the certified shares or revenue received from local income taxes from 1.40% to 1.90% (an increase of .50%) and decreasing the property tax relief credit percentage from 1.00% to .50%. The result would be more revenue received by the County and all taxing units with the exception of the school corporations. The additional revenue could help to eliminate the supplementation from the EDIT Fund and possibly eliminate borrowing from other county funds until the property tax distribution is received semi-annually.

At the request of Council member Bowman, Bates had created a specific comparison of percentage credit options if the current 1.00% property tax relief

credit were decreased to .75% or to .50% for homesteads, rentals, and farmland and the resulting property tax paid. Bates reviewed this comparison in detail and explained the reasoning behind suggesting the rearrangement of .50%. He stated that any of the credit percentages on the comparison sheet would result in much less tax paid when compared to the amount of property tax paid in the year 2007 and before. He reminded Council of the years that homeowners paid no or close to no property taxes because of the property tax levy freeze and the division of income tax credits which resulted in not enough revenue to cover necessary General Fund county services. Bates answered questions from Council members.

Chairman Dawes opened the discussion to the public for their questions. County resident Mike Ridenour asked if there is a maximum percentage or amount that is allowed by law to be rearranged. Bates stated that there are limits within each category (public safety, economic development etc.) but as long as there is no increase in the overall total of the income tax rate, Council can rearrange the percentages according to what is best for the county. The law changed this year regarding the review and changes that can be made by Council.

Mr. Ridenour commented that homeowners represent the largest segment of the community that contribute property and income taxes that are guaranteed to help fund the expenses of the county, so they should be getting the most benefit from the property tax relief credits. Bates stated that he has checked with the IRS and county businesses and farmland contribute a higher percentage of income taxes to the community. Bates stated that Wabash County remains the lowest county in the state for homeowners' property tax bills and it is the second highest county for income tax rates. He said that this is exactly the purpose for the recommendation of increasing the certified shares and decreasing the property tax relief to homeowners. The rearrangement of percentages would reduce property taxes overall in the county and there would be no increase in the current income tax rate. Chairman Dawes stated that when the County Budget Committee met with Purdue University professor Larry DeBoer, they asked him to recommend a possible scenario for increasing revenue while not increasing income taxes. Dawes stated that this rearrangement of shares and property tax relief is the one that DeBoer recommended. Councilman Dale asked questions regarding the current division of 40%, 40%, and 20% credit percentages utilizing the current \$6,500,000 in property tax relief. Bates stated that the percentages came out differently because some of the credits are overlapping. He said that these percentages can never be absolute compared with the amount for certified shares and for PSAP distribution.

Mr. Ridenour asked if consideration was given to eliminating all income tax credits from property tax relief which would lessen the income tax paid by county residents. Bates responded that eliminating all income tax would

increase property tax bills and would increase property tax caps substantially. Bates stated that the rearrangement of percentages and reviewing this again in future years could greatly assist the County to be able to fund necessary services but that in three to four years, all counties will need and expect the State to make changes in Indiana's tax system. Bates again stated that there would be no increase in the current total Local Income Tax (LIT) rate of 2.90% and that a decision will need to be made and submitted to the DLGF before the October 31, 2017 deadline.

Chairman Dawes stated that a decision would be made at the October 16, 2017 LIT/PSAP public hearing, since the decision regarding the rearrangement of percentages involves the consideration of the PSAP income tax option.
