

**WABASH COUNTY COUNCIL MEETING AND**  
**FINAL ADOPTION HEARING OF THE 2019 COUNTY BUDGETS AND THE**  
**PUBLIC HEARING FOR THE SOLID WASTE MANAGEMENT DISTRICT 2019**  
**BUDGET**

The Wabash County Council met in session on Monday, September 24, 2018 in the Commissioner's Meeting Room of the Wabash County Courthouse.

Chairman Randy Curless called the meeting to order at 5:00 P.M. Six Council members were present: Curless, Lorissa Sweet, Matt Dillon, Philip Dale, Kyle Bowman and Barbara Pearson. Matt Mize was absent. Bowman opened with a word of prayer and Curless led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Curless requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the August 27, 2018 Council meeting. Dillon made a motion to approve the minutes. Pearson seconded the motion and it passed by a 6-0 vote.

In regard to the 2019 budget hearing proposals, the following additional requests were heard:

Sheriff Bob Land requested an increase in the life and disability insurance amounts provided in the Sheriff Department's pension program for 2019. The current amount is \$25,000 per active officer and the request was to increase the amount to \$50,000 per active officer. Land stated that the cost increase for the additional insurance would be \$2,700 per year to be paid from the Sheriff's Pension Fund. Bowman asked if the current insurance is in addition to the County employees' insurance policy, which is \$25,000 life insurance for all full-time employees. Auditor Shepherd suggested that the request be tabled in order to verify the exact cost to the Sheriff's Pension Fund. No further discussion was heard. Dillon made the motion to approve the request for more insurance coverage to be included in the 2019 budget. Sweet seconded the motion. The motion passed by a 5-1 vote with Dale voting against.

Sandy Beeks, Wabash County Central Dispatch Director presented a Power Point demonstration on the duties of a dispatcher. Beeks stated that with the Town of North Manchester closing their dispatch center, she will need four new employees to handle the additional call volume. Council member Dillon stated that he was in agreement that additional employees would be necessary to maintain the dispatch call volume. Council member Bowman stated that two new positions were included in the 2019 budget, but that he opposed a total of four more dispatchers, at this time. He stated that the County generally does not eliminate positions, and believes that if additional people are required once North Manchester is included in the dispatching services, it would be best for

Beeks to request additional dispatchers if they are needed, at that time. Dillon made the motion to approve two additional dispatchers. The motion died for lack of a second to the motion.

Under the business of the regularly scheduled Council meeting, the additional appropriations requests were heard. Present for the request was Sheriff Bob Land and Sandy Beeks, Central Dispatch Director.

## WABASH COUNTY SOLID WASTE MANAGEMENT DISTRICT'S 2018 BUDGET HEARING

County Council Chairman Curless opened the advertised hearing of the Wabash County Solid Waste District's proposed 2019 budget for discussion and public input. Present for the hearing were Wabash County Solid Waste Director, Jen Rankin and Solid Waste Board member, Ken Ahlfeld. The Council suggested no decreases, increases or changes to the budget as proposed. No public comment was heard. The final adoption hearing is scheduled for October 22, 2018.

### FINAL ADOPTION HEARING OF THE 2019 WABASH COUNTY BUDGETS

Council's consensus was to approve the budgets as previously modified at the Sept. 13<sup>th</sup> budget hearing with salary increases as designated, decreases to the proposed budgets as designated, and the transfer of certain expenses as designated. The General Fund budget also includes the \$215,747 in property tax caps. Council requested the addition of \$2,700 to the Sheriff's Pension Fund for the previously approved increase. Upon approval by Council, the estimated property tax levy will be approximately \$104,811 over the maximum levy allowed, but the levy and tax rates will be officially determined by the Department of Local Government Finance (DLGF) after submission of the budgets and tax levies by the Auditor's office. The DLGF must certify the 2019 budget before, or by February 15, 2019. Dale made the motion to approve the 2019 budgets. Bowman seconded the motion and it passed by a 5-1 vote. Dillon voted against the budget approval with no comment.

During the budget hearings, Clerk of the Courts, Elaine Martin requested Council's approval to begin the process of updating the county's voting machines. She reported that the machines would need to be updated prior to the November 2018 election because of needed changes including too much verbiage. Unless updated, the machines cannot contain all the required information. The election machines vendor, Microvote has agreed to update the machines this year and wait for payment in 2019. Pearson made the motion to approve the request. Dillon seconded the motion and it passed by a 6-0 vote.
