

WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, October 22, 2018 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Randy Curless called the meeting to order at 5:00 P.M. Six Council members were present: Curless, Matt Mize, Matt Dillon, Lorissa Sweet, Philip Dale and Kyle Bowman. Council member Barbara Pearson was absent. Councilman Bowman led in a word of prayer and Curless led the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Curless requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to review the minutes of the September 11th, 12th, and 13th budget hearings for 2019 and the September 24th budget hearing adoption for 2019 and the September 24, 2018 regularly scheduled Council meeting. Dillon made a motion to approve the minutes for the budget hearings and for the regular September meeting. Dale seconded the motion and it passed by a 5-0 vote with Mize abstaining due to his absence from the September 24th meeting.

The next order of business was the advertised final adoption of the Wabash County Solid Waste Management District's 2019 budget. Solid Waste Director Jen Rankin was present in order to answer questions and address comments. No questions or public comments were heard. Dale made a motion to approve the Wabash County Solid Waste Management District's 2019 budget. Dillon seconded the motion and it passed by a 6-0 vote.

The next order of business was to address the 2019 Wabash County Salary Ordinance created from the 2019 Wabash County Budget Adoption as approved on September 24, 2018. Dale made a motion to approve the 2019 salary ordinance as submitted. Dillon seconded the motion and it passed by a 6-0 vote. Dillon made a motion to suspend the rules requiring a second reading of the ordinance. Sweet seconded the motion and it passed by a 6-0 vote.

The next order of business was to address the requests for a Transfer of Funds from one budgeted line item/account to another. Present for the requests were County Extension/Health & Human Science Educator Mindy Mayes, and

Commissioner Brian Hauptert. Superintendent John Martin was not present for his request.
