

# WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, June 17, 2024 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Matthew Mize, Philip Dale, Gary Ridenour, Sam Hann and Nick Kopkey. Matt Dillon via Zoom. Bowman opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

First order of business was a review and approval of the minutes from the May 20, 2024 meeting. Hann made a motion to approve the minutes as presented. Dale seconded the motion; it passed by a 6-0 roll call vote, Bowman abstained due to not being present in May.
