## July 19, 1999

Council Chairman, Ted Little, called the meeting to order in the courthouse at 8:00 a.m. with all members attending. Leon Ridenour shared a prayer, and minutes of the 6/7meeting were approved as written, moved by Richard Pepple, second by Paul Sites, and passed. Heard from Co. Surveyor, John Stephens, that a 3% loan application thru the Dept. of Natural Resources has been denied for the Urbana Drainage Project. The DNR ruled our project is a drainage and storm sewer project rather than a flood prevention project. John will appeal, but in the meantime he's researching alternatives so the project could begin this October. He will contact local banks to learn their rates, since he must have financing lined up before holding a public hearing with Urbana residents who must contribute \$160,000. toward the project. Funding of \$500,000. was approved last year, but since that's limited to \$50,000. every six months, it will be used to repay a loan. Council strongly advised Stephens to appeal the DNR decision, with petitions and personal visits to the DNR by a group of supporters. Co. Assessor, Kelly Schenkel, advised there aren't any available level 2 trained people to sit on the Property Tax Assessment Board of Appeals (PTABOA). People from other counties won't come here for the Council set pay of \$50. a day. Council consensus is to work with the current 3 member board, as this is a statewide problem the legislature will have to address. Gary Nose moved to approve Resolution 1999-4, which prohibits distributing CAGIT money to the Wabash Co. Solid Waste District, second by Eugene Schenkel, and passed. Rich moved to approve Resolution 1999-5, which allows transfer of \$111.13 from the dormant 1995 Cumulative Reappraisal Fund to the current 1999 Cumulative Reappraisal Fund, second by Gary, and passed. The public hearings for the 2000 budget are set for Monday and Tuesday August 16th & 17th beginning at 2:00 p.m. each day.
