January 29, 2001

Leon Ridenour called the meeting of the Wabash County Council to order at 8:00 A.M. with all members present. Leon brought prayer and welcomed returned member Joann Rauh. The Auditor conducted election of officers for 2001. Gary Nose was selected as chairman, moved by Paul Sites, second by Eugene Schenkel, and carried. Leon was approved as vice chairman, moved by Paul, second by Ted Little, and passed. Minutes of the 12/4 meeting were approved as corrected, moved by Gene, second by Paul, and passed. Gary voted nay on the Wards of Court additional appropriation request and yes on the Circuit Court Pauper Appeals request. Minutes of the 1/12/01 meeting were approved as written, moved by Richard Pepple, second by Ted, and passed. Gene moved to re-appoint Phillip Mendenhall to the Alcoholic Beverage Board for 2001, second by Rich, and passed. Gene moved to appoint Gary as the Council representative on the museum relocation board for 2001, second by Ted, and passed. Council learned the judicial building project is about 5 1/2 months behind schedule, 60% of the job management fees have been paid and only about 20% of the work is complete. The management contract expires in May, and the project will be far from completed. Four staff members at the beginning of the project are no longer with Prince/Alexander, and there may not be sufficient staff left to honor the contract. They also learned Life-Med ambulance service is operating with additional funds from the county, thru March. Commissioner Haupert says there isn't anyone else interested in the job, and if Life-Med is terminated, there's no coverage for the northern part of the county. Barry Hicks, representing the Sheriff, asked to transfer funds budgeted for an additional dispatcher in the jail, to the Sheriff's budget for another deputy. Council can't act on this, until it's been advertised.
