The Wabash County Council met August 24, 2005 at 8:00 A.M. in the former Circuit Court Room of the Wabash County Courthouse. Chairman Paul Sites called the meeting to order with six Council members present. Leon Ridenour was unable to attend due to family illness. Prayer was offered by Dean Eppley.

Minutes for the July 25th meeting were reviewed and approved as written on a motion by Little, seconded by Eppley and a 6 to 0 vote.

The Prosecutor's office is separating its equipment from Pillar Corporation's equipment and making personnel changes. Two transcription kits for two secretaries were needed to make them compatible with the prosecutor's dictating recorder. That total is \$306.22. A digital dictating recorder is needed for the new Chief Deputy Prosecutor so she can dictate to the secretaries and that cost is \$237.64 for a total of \$543.86. Also the Prosecutor's office was using two filing cabinets that belonged to Pillar Corporation and, therefore, need to be replaced. A quote was received (verbally) from K & R Office Supply for \$179.99 each for a legal sized filing cabinet for a total of \$359.98.

Following discussion, Little moved to approve the transfers for Community Corrections as requested, seconded by Nose and passed by a 6 - 0 vote.

Wabash County Recorder Nancy Gribben requested the council establish a new County Identification Security Protection Fund as required by law. Council reviewed the following ordinance she presented:

ORDINANCE 2005-4 COUNTY IDENTIFICATION SECURITY PROTECTION FUND

WHEREAS, Indiana Code 36-2.7,5-6 Senate Bill 503, the Wabash County Council must establish the Identification Security Protection Fund by January 1. 2006.

WHEREAS, This fund is for depositing \$2.00 from the recording of a declaration form, which must be recorded with every document. According to the statute, this fund shall be administered by the Recorder and appropriated by the County Council. It may only be used for the purchase, upgrade, implementation and maintenance of redacting technology for the Recorder's office.

WHEREAS, the fund shall be established for the time period of January 1, 2006 through June 30, 2011 at which time the \$2.00 being collected will revert to the County General Fund.

Following review of the above ordinance, the County Identification Security Protection Fund was adopted on a motion by Nose, seconded by Eppley and passed on a 6 - 0 vote.

Council reviewed the July 31, 2005 Financial Statement and also the current August 23, 2005 Financial Statement.

Bergman moved to adjourn the regular monthly meeting to begin the departmental 2006 Budget Hearing workshops scheduled and advertised for August 24, 25 & 26, seconded by Fuller, so adjourned by a 6 - 0 vote. The next meeting will be September 7, 2005 to conduct regular county business and adopt the 2006 Budget. The council will meet on the second floor of the Wabash County Courthouse at 8:00 A.M.
