## OCTOBER 23, 2006

The Wabash County Council met in regular session on October 23, 2006 at 8:00 A.M. in the Wabash County Courthouse. Chairman Bob Fuller called the meeting to order with all seven Council members present. Prayer was offered by Leon Ridenour.

The minutes of the September 11 meeting were reviewed. Eppley moved to approve the minutes with one amendment and his motion was seconded by Little and approved by a 7-0 vote.

The first order of business was to address the following additional appropriation requests as advertised and presented in Additional Appropriation Ordinance 2006-X.

Accordingly, this additional appropriation is needed for future costs of petit jurors which we anticipate at this time. Circuit Court has talked with the State, who anticipates that two criminal trials are likely to take place within the next month. The Circuit Court does not know at this time the status of any civil trials which are set for trial

Wabash County Judge McCallen informed the Council that the petit jurors funds are at a deficit and there are still jurors to be paid this year for trials yet

Council discussed with Kathy Carter-Lower, Health Department, if the shots were only for Wabash county residents. Kathy stated sometimes folks from other counties do get the shots. Bergman stated it is okay if they receive the shots as long as they pay for the shots. Ridenour motioned to approve request. It was seconded by Nose and passed with a 7-0 vote.

Council also discussed with Carter-Lower the advertised position for the Health Department. The position had salary changes over the year due to responsibilities added. Now the responsibilities had been reduced thus the salary was reduced to its original amount. Council felt no changes should be done at this time regarding the salary budgeted.

It was seconded by Eppley and passed with a 7-0 vote.

Commissioner Templin stated funds from the CCD fund for a building repair projects had been depleted and this request is needed for estimated repair projects for the year. Bergman motioned to approve. It was seconded by Eppley and passed with a 7-0 vote.

Fuller presented the Salary Ordinance for 2007. Six (6) of the seven (7) Council members had not received the Salary Ordinance. Little motioned to table any discussion for the December meeting so that all members can review. It was seconded by Bergman and passed with a 7-0 vote.

Striker informed Council that information is to be presented to the Commissioners today from an advisory board concerning the Central Dispatch issue. These facts are for the Commissioners to review and to determine how to proceed with the Central Dispatch idea.

Kelly Schenkel, Wabash Co. Assessor, informed Council her server is about ready to crash. Schenkel stated she was unsure whether to fix her current system or completely replace it. The cost could be anywhere from \$300.00 to \$10,000.00. Council decided Schenkel needed to take this concern to the Commissioners.

Lori Draper, Clerk of the Courts, reported voting machines for the upcoming election from Microvote are currently being borrowed. The machines are all certified and have new hardware. Draper stated she is waiting on a quote to possibly purchase the machines. Draper also informed Council she is saving money by using current employees to maintenance machines rather than outsourcing mechanics.

Council discussed options on renovating or building new regarding the county Jail. Council decided to create a volunteer committee from the Council to look into options. Bob Fuller, Gary Nose, and Ted Little volunteered to move on being proactive on changes, renovations, and concerns facing our current Jail.

Council discussed the new phone system change. Little asked if any upgrades and costs need to occur before the system will work come January 1, 2007. Commissioner Templin stated it is ready to go at the present time. Templin

also stated upgrades may need to be done in the future and that would be at an hourly rate with Verizon.

No other business, the meeting was adjourned on a motion by Ridenour, seconded by Nose with a 7-0 vote. The next regular meeting will be December 4, 2006. The council will meet on the second floor of the Wabash County Courthouse at 8:00 A.M.
