This request was presented as advertised and read in full at the March 27, 2006 meeting and was tabled. It was presented again at the April 24, 2007 meeting and remained tabled. Little moved to take this additional appropriation request off the table for discussion and Eppley seconded the motion. It was then presented and read a third time and after much discussion Little motioned to approve for the amount of \$17,257.52 (the amount now requested by the Sheriff due to year-end appropriation transfers from within his budgets). Little's motion was seconded by Eppley and approved by a 4-2 vote. Little, Eppley, Fuller and Markstahler voted aye, Bergman and Ridenour voted nay. (Nose abstained from voting).

Council discussed an ordinance to raise the part-time hourly pay scale to a

range of \$5.95-\$10.95 an hour to include a 3% increase based on the 3% increase given to salaried employees in the 2007 budget. Due to lack of motion the ordinance was not implemented.

Council received a letter from the Roann Paw-Paw Township Public Library requesting Max Gaston be the Council appointee to the library board to assume the remainder of Ashley Cordes' term, ending February 20, 2007. Nose made a motion to approve the appointment. His motion was seconded by Eppley and approved with a 7-0 vote.

Council also received a letter from the Wabash County Tourism Commission recommending the appointment of Claude Markstahler as the new representative from the Wabash County Council. He would be filing the unexpired term of Leon Ridenour that would expire on December 31, 2007. The WCVB gave their thanks to Leon Ridenour for his much appreciated time as the appointed representative. Eppley motioned to approve Markstahler as the appointee from the County Council. The motion was seconded by Ridenour and approved with a 7-0 vote.

A Special Session of the Wabash County Council was set for December 11, 2006 at 8:45 A.M. to consider an Additional Appropriation request by the Board of Commissioners from the Wabash County CEDIT Fund for a LaFontaine TIF District and for the Economic Development Group (EDG) proposed amendment to the Capital Improvement Plan for Wabash County. Council also decided to call an Executive Session to be held on December 11, 2006 at 8:00 A.M. at the Wabash County Courthouse to discuss personnel matters prior to the Special Session.

Council Chairman Fuller asked all present to move to the first floor of the Courthouse for a surprise reception to show appreciation and honor the retirement of Council members: Leon Ridenour and Paul Bergman as well as Wabash County Commissioner Darle Dawes. The reception was co-hosted by the Wabash County Convention and Visitor's Bureau and was attended by some of the honorees' family members, friends and county employees.

No other business, the meeting adjourned on a motion made by Ridenour, seconded by Eppley and approved with a 7-0 vote. The next meetings will be the Executive and Special Sessions on December 11th on the second floor of the Wabash County Courthouse at 8:00 A.M.
