JANUARY 22, 2007

The Wabash County Council met in regular session on January 22, 2007 at 8:00 A.M. in the Wabash County Courthouse. Auditor, Jane Ridgeway, called the Organizational meeting to order, welcoming the two (2) new members: Mike Ridenour and James Kaltenmark. All other Council members were present: Bob Fuller, Dean Eppley, Ted A. Little, Gary S. Nose, and Claude Markstahler. Ridgeway opened the floor for nominations for Chairman of Council for the 2007 year. Ted Little nominated Bob Fuller as Chairman. It was seconded by Dean Eppley and unanimous that nominations be closed. Fuller was approved as Chairman by a 7-0 vote. Fuller then opened the nominations for Vice-Chairman for the year 2007. Ted Little nominated Gary Nose. His motion was seconded by Markstahler and it was unanimous for the nominations to be closed. Nose was approved as Vice-Chairman by a 7-0 vote.

The minutes of the December 4, 2006 regular meeting were reviewed as well as the minutes of the December 11 Executive Session, December 11 Special Session and the December 18th Special Session. Eppley moved to approve the minutes as written. It was seconded by Markstahler and approved by a 5-0* vote. The minutes for the September 11, October 23, December 4, and December 11, 2006 were signed by Council—these had been previously approved but not printed in large bound book form due to a printer problem.

The first order of business was to address the following additional appropriation requests as advertised and presented in Additional Appropriation Ordinance 2007-I.

Part of that ordinance included requests to establish new department budgets for a Wabash County Alcohol and Drug Court Program and a new Wabash County Drug Court. Judge Christopher Goff, Wabash Superior Court and Chief Probation Officer Dallas Duggan were present to explain the creation and purposes of the two new programs. Duggan discussed with Commissioners a plan to discontinue with a contract based Alcohol and Drug Court program which has been run through the Otis Bowen Center. Duggan stated the State recommended a County based program which would be operated, like in the past, without using any Wabash County tax monies. Duggan submitted a budget request of \$54,343.40 including one time start-up costs for Capital Outlay expenditures of \$6,340.00 for Office Equipment, Furniture and Fixtures, etc. Duggan also stated Judge Goff is requesting approval to charge a fee to the offenders for \$300.00 per referral. This fee, based on a 175 minimum referral number, would be collected and help fund the A&DC Program. Duggan also stated a full time employee, Case Director—Certified Probation Officer—paid from User Fee Fund would need to be hired. Council stated the New Salary Ordinance would need to be amended if this passes and the position would need to be advertised. Eppley made a motion to* approve both the Wabash County Drug Court budget requests of \$12,000. and the Wabash County Alcohol and Drug Court Program Budget as presented. This motion was seconded by Kaltenmark and approved by a 7-0 vote. It was mentioned that Duggan would need to advertise for the case manager position.
