JANUARY 28, 2008

Wabash County Council met in regular session on Monday, January 28, 2008. Prayer was offered by Jim Kaltenmark. Chairman Bob Fuller called the meeting to order at 8:00 A.M. with all members present: Dean Eppley, Bob Fuller, Gary Nose, Jim Kaltenmark, Mike Ridenour, Ted Little, and Claude Markstahler. Wabash County Auditor Jane Ridgeway recorded the minutes of the meeting.

The minutes of the December 3, 2007 Regular Session were reviewed. Eppley made a motion to approve the minutes as written. The motion was seconded by Kaltenmark and approved by a 7-0 vote. The minutes of the January 7, 2008 Special Session meeting were then reviewed. Eppley moved to approve these also with one typo correction (DLGF). Ridgeway stated that she had already corrected the tense usage in the second to the last paragraph were Ridenour discussed possibly "holding" some evening meetings in 2008 to better accommodate the public. Ridenour commented that he would like to be sure to change the set time of the 2009 budget hearing meetings to evening hours. Fuller agreed this could be done and suggested advertising the Budget hearings for 4:00 P.M. each of the three scheduled days in August of 2008. In further review of the January 7th minutes, Little asked to be certain that concerning the Economic Development Commission Resolution, the comments from County Attorney Steve Downs were included in the minutes regarding "no financial responsibility of the county". The Auditor read from the minutes as follows: Answering questions from the Council, Corsaro stated and Downs concurred, there will be no liability to Wabash County for these Tax Exempt bonds: "No direct or contingent liability." Ridenour then moved to second the minutes as amended and the minutes of January 7, 2008 were approved by a 7-0 vote of the Council.

Lalon Allen, President of the Extension Advisory Board, discussed with Council the currently vacant staff position and the upcoming retirement of County Extension Director Nancy Radabaugh which will leave a second position available starting March 1, 2008. There was funding for a full time Agricultural Assistant position added to the contract with Purdue for 2008. This was previously a part time position held by Matt Moorman. Allen explained that applications are currently in the screening process by Purdue. Once Purdue has reviewed the candidates, then the process of interviewing begins. Eppley asked if a time frame was available. Allen stated there was no real time table set. Allen presented a resignation letter from Moorman with his explanation. Council discussed how they would have liked Moorman to stay in the position. They felt he had done an exemplary job, but did understand his choice to pursue other things. Allen requested permission to move forward with the process and possibly hire if a candidate was found and approved by

Purdue. Council agreed by consensus to move forward with the process and noted that the contract funding should be amended if the positions are not filled for the entire year. Council requested that Radabaugh keep the council apprised as to where they are in the process. Allen agreed he felt communication with Council was a key priority during this process and they would be informed of progress on both hiring positions.

The next item on the agenda was David Young Chairman of Wabash County AACTION who along with Danette Norman, Director of Counseling Services of Manchester College, reviewed the recommendations for the 2008 Drug-Free-Communities Grant Recommendations with Council. Council discussed the Bowen Center monies and the North Manchester College program that allows for pamphlets in the restrooms for college students to read. Fuller thanked Young for all the hard work done with these grants. Nose made a motion to approve and appropriate the following AACTION grant requests as presented. His motion was seconded by Little and passed with a 7-0 vote.

Brenda Conner Noble Township Assessor discussed with Council her concerns on the salary for her deputy. After much discussion on the issue, Fuller stated the salary issues need to be reviewed, employee evaluations completed and a set system for merit/longevity pay put into place by County Coordinator Jim Dils before budget hearings for 2009. He asked that the Commissioners and Department heads work with Dils during this process. Little made a motion to approve the Amended Salary Ordinance for 2008 as presented. It was seconded by Ridenour and passed by a 7-0 vote.

Ridgeway presented Encumbrances filed by Department heads for the Council to review and approve. Council requested a separate column on the Budget Status Reports so that encumbered appropriations from 2007are not confused with the transfers and additional appropriations of the 2008 budget funds. Ridgeway stated she would attempt to design a new report to make this distinction in the future. Markstahler made a motion to approve the Encumbrances presented. His motion was seconded by Eppley and passed with a 6-1 vote. Little opposed because he had not been able to review the Encumbrances.

Council asked Wabash County Auditor Ridgeway how the property tax rebate process was moving along. Ridgeway stated she had calculated the rebates on December 11, 2007 and sent the file to Boyce Systems which was contracted to process the rebate checks. She copied the file for the Treasurer's office who was currently checking through the over 10,358 rebates for outstanding delinquent taxes so that the rebates could first be applied to any taxes owed. Last week it was discovered there had been a problem with the Manatron MVP Tax program written for this first-time process and it has caused a set back for all counties on the MVP Tax system. Over 100 parcels were missed in Wabash County by the error. Currently Manatron is attempting to correct the problem in the software. No time table was available for when the rebates will go out but Ridgeway noted as soon as the software corrections were available she would re-calculate the files and send them again to Boyce, then the Treasurer

will mark all delinquencies and the files can be sent to Boyce again for processing and mailing checks to qualifying taxpayers. She also stated the individual rebate amounts are currently available online at the Wabash County website.

Council reviewed the *DLGF Memorandum: 2008 Expenses and Obligations* from the January 7, 2008 meeting and discussed the current status of the State certification of the 2008 Budget. Ridgeway informed them that Wabash County Assessor Kelly Schenkel had received approval on the 07pay08 Trending ratios on January 11 which had allowed her to print and mail F11s (Notices of Changes in Assessment) to all taxpayers affected. They mailed approximately 17,000 F11s on Friday, January 25th. The taxpayers now have 45 days to question and appeal the assessments. In the meantime, the Auditor's office will be working to verify exemption values and reconcile values by taxing districts. When Schenkel is finished making approved changes the values can be rolled to the Auditor's MVP Tax System and then the final values can be verified and certified to the State – which is the next step in the budget process.

Council reviewed the following items:

- 1. Local Option Income Taxes: State Budget Agency.
- 2. December 31, 2007 Financial Report.

Ridenour made a motion to adjourn, seconded by Little and the meeting closed with a 7-0 vote.
