# **MARCH 24, 2008**

Wabash County Council met in regular session on Monday, March 24, 2008 at 8:00 A.M. in Commissioners' meeting room of the Wabash County Courthouse.

Prayer was offered by Jim Kaltenmark. Chairman Bob Fuller called the meeting to order at 8:00 A.M., with all members present: Dean Eppley, Bob Fuller, Gary Nose, Jim Kaltenmark, Mike Ridenour, Ted Little and Claude Markstahler.

The minutes of the February 25, 2008 were reviewed. Eppley made a motion to approve as written. The motion was seconded by Ridenour and approved by a 7-0 vote.

Bill Konyha, CEO/President of the Economic Development Group of Wabash County (EDG), presented two (2) ordinances concerning the POET –North Manchester Ethanol Plant for First Reading as follows; 1) Tax Increment Revenue Bonds, and 2) Solid Waste Facility Revenue Bonds. Following discussion, Eppley made a motion to approve the first reading of both ordinances. It was seconded by Little and passed with a 7-0 vote. Council also set a Special Session Meeting for April 10, 2008 for final approval on the Ordinances following the action of the Economic Development Commission and the Redevelopment Commission Public Hearings on the ordinances.

Marilyn McDonald, Wabash County Coroner, filed a claim with the Auditor's office for a bill received from Life Med. in December, 2007 for three (3) fire victims transported from North Manchester to Wabash and then to Fort Wayne. The bill totaled \$4,092 for the transport of all three (3), but in one trip. Council stated they thought it was a triple fee for one transport - Nose stated it appeared to be "false billing". The invoice had already been paid through the available budgeted funds for the new year, causing the Coroner's 2008 budget to be drained for the upcoming year's expenses. Council wanted these to be reviewed by County Attorney Steve Downs. Council discussed with McDonald that she turn in her claims in a timelier manner to avoid further issues with her budget. The amended additional request for the Coroner was reviewed and tabled by the Council. Eppley made the motion to table. It was seconded by Ridenour and passed with a 7-0 vote. Council also discussed with the Coroner other transportation quotes from Freels Enterprise; \$85.00 for transport between two (2) points in Wabash County and \$150 from Wabash County to North of Indianapolis, with other locations to be decided if need be. Also, body bags would run \$10 - Life Meds are \$70 per bag. Eppley made a motion to allow \$10,000.00 of the Additional Appropriation requests, but his motion died for lack of second. Following more discussion, Ridenour made a motion to deny the amended additional requests. His motion was seconded by Markstahler and passed by a 7-0 vote. They asked

that future claims be brought to them for consideration as presented. NOTE: Following the Council Meeting, McDonald received and gave to Auditor Jane Ridgeway from Life Med a check totaling \$2,728.00. Life Med agreed to refund the over-charges for the three fire victims and only charged as one transport.

Council also reviewed a letter from Indiana State Coroners Training Board with McDonald. It stated that two of her deputy coroners had not successfully completed the required courses as described by I.C. 36-2-14-23. The ISCTB has requested that all payment to the two (2) deputy coroners be withheld until said persons have successfully completed the required training. The two Deputies are not county employees. They are paid as independent contractors.

Teresa Witkoske who is interim Wabash County Extension Director updated Council on the two (2) positions in the Extension Office. Nancy Radabaugh's 4-H Youth Educator position will be filled by Pandora Woodword. She is set to start on April 9, 2008. Currently Woodword will be filling the position of Nancy Radabaugh, but will not be taking on the Director Title that Radabaugh also filled. Witkoske will hold that position until qualifications are met by current or future staff. The Ag and Natural Resources Educator Position formerly held by Matt Moorman is currently still open and the position will be re-advertised by Purdue.

Sheriff, Leroy Striker, reviewed a claim he had received and submitted to the Commissioners totaling \$127.37 requesting funds be paid by the county to the Wabash City Police for the Transport of EDO (Emergency detention order) from Wabash County to the Bowen Center of Warsaw. In the past, the Sheriff's department would always handle the EDO's. Striker stated he could find no law that stated the County as the transport source. Also, Striker had found no other county that has had a claim in this manner. Striker contacted the State Board of Accounts and no set fee had been set.

Striker stated there is no conflict between the County and City Police. He just wanted to know who will pay this and how to handle in the future with transport of EDO's. Council will take under advisement.

Council reviewed a letter from the DLGF informing them that the Indiana General Assembly House Enrolled ACT (HEA) 1001 transfers the township assessor's duties to the county assessor in all townships with parcels fewer than 15,000, effective July 1, 2008. Along with this letter came a Potential Circuit Breaker Credits report showing the changes after this transfer of assessor's duties takes place for the 2009 and 2010 years.

Council also reviewed the February 29, 2008 Financial Report. Councilman Little told Council that Wabash County is one of the first seven counties and currently Wabash County is one out of eleven, with all the Budget and Assessment data filed and are ready and waiting on the State to finalize our tax rates and hold budget hearings.

Wabash County Resident Jim Dixon came before the County Council with no request, no complaint; needing nothing. Dixon merely expressed to the Council to know how much he appreciated all the hard work that they do for Wabash County.

No other business, Eppley made a motion to adjourn, seconded by Kaltenmark and the meeting closed with a 7-0 vote.
