## **OCTOBER 26, 2009**

Wabash County Council met in regular session on Monday, October 26, 2009 at the Wabash County Courthouse. Prayer was offered by Jim Kaltenmark. Chairman Mike Ridenour called the meeting to order at 5:00 P.M. with all members present: Gary Nose, Jim Kaltenmark,

Mike Ridenour, Ted Little, Daryl Evans, Claude Markstahler and Randy Curless. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the minutes of the September 8, 2009 meeting and the October 19, 2009 Joint Executive Session meeting. Curless made a motion to approve the September 8, 2009 minutes as written; his motion was seconded by Evans and passed by a 6-0 vote. Ridenour read the minutes for the October 19, 2009 Joint Executive Session meeting minutes. Ridenour stated there was one word change; "or" to "of". Little made a motion to approve the minutes of the October 19<sup>th</sup> Joint Executive Session with the one change; his motion was seconded by Curless and passed by a 6-0 vote.

Curless made a motion to approve request to transfer \$400 to Other Garage & Motor; his motion was seconded by Kaltenmark and passed by a 7-0 vote.

This was presented to the Wabash County Council, read in full, and adopted on the 26<sup>th</sup> day of October, 2009, by the above aye and nay vote.

# **OTHER BUSINESS:**

## August 31 and September 30, 2009 Financial Reports - Auditor & Treasurer

Auditor Ridgeway stated that CEDIT and LOIT come each month with the same distribution. There will be an adjustment in November 2009. This is a fractional portion of the certified distributed of Wabash County's budget.

## **Appointment for North Manchester Public Library Board**

Little made a motion to approve Lisa Ulrey as Council's appointee to the North Manchester Public Library Board; his motion was seconded by Markstahler and passed with a 7-0 vote.

## **Proposed Meeting Schedule for 2010**

Council reviewed the 2010 Council scheduled meetings and the State Holiday dates for 2010. Council changed:

- 1. March 2010 meeting to be held Monday, March 24th.
- 2. Council discussed the time for the budget hearings in 2010. Council set budget hearings to be held on the 17<sup>th</sup> and 18<sup>th</sup> of September at 12:30 P.M. and the meeting on the 19<sup>th</sup> of September to be held at 4:00 P.M.
- 3. Council discussed the idea of changing Council meeting days and/or times. Nose stated the 5:00 P.M. Council meeting may need to be moved to a 6:00 P.M. meeting time for those working. Little stated we

had moved the meeting to the 5:00 P.M. evenings for the public to attend and many of the meetings have had a high attendance. EMA Administrator Bob Brown stated The Wabash City Council holds meetings twice per month and one of them does fall on the 4<sup>th</sup> Monday at 6:00 P.M. one hour after the County Council meeting. Ridenour stated in the future a special time or date could be set for high profile issues that may need an extended amount of time. Evans made a motion to keep the current 5:00 P.M. time on the 4<sup>th</sup> Monday of each month; his motion was seconded by Little and passed by a 6-1 vote. Nose opposed.

# Decrease of Mileage Reimbursement from \$.44 to \$.40.

Mileage decrease was previously approved by the Commissioners. Evans made a motion to decrease mileage from \$.44 to \$.40; his motion was seconded by Curless and passed with a 7-0 vote.

## **Jeff Hobson, Community Corrections**

During the 2009 Budget hearings, Hobson presented a salary increase request for Community Corrections. Hobson stated Community Corrections budget is six (6) months behind other budgets and what was received by other county employees in January of 2009 would not be set in motion until July of 2009 for Community Corrections. At that time, Council decided to deny the salary increase request due to a mandate by the State denying any salary increases. Hobson presented the argument at the October 26th meeting that County Council does not have the deciding authority to deny the salary increase request for the July 2009 budget request once it had been approved by the Community Corrections Advisory Board. Hobson presented a memorandum from County Attorney Steve Downs. Downs stated this involves two Indiana Codes: I.C. 11-12-2-3.5(b) and 36-2-5-2(b)

## I.C. 11-12-2-3.5(b):

"The community corrections advisory board may establish personnel policies, procedures, and salary classification schedules for its employees. Employees of a community corrections program are county employees. The policies, procedures, and schedules established under this subsection may not be inconsistent with those established for other county employees."

### I.C. 36-2-5-2(b)

"The county fiscal body shall appropriate money to be paid out of the county treasury, and money may be paid out of the treasury only under an appropriation made by the fiscal body, except as otherwise provided by law"

Hobson stated I.C. 36-2-5-3(d) states that this does not apply to Community Corrections (as defined in I.C. 11-12-1-1 and I.C. 35-38-2.6-2)

Hobson stated community correction meets all of the requirements set forth in I.C. 11-12-1-1 and 35-38-2.6-2. Hobson stated he had sought legal advice outside the county and had been advised that he was within his rights legally to obtain the salary increases on the Community Correction Advisory Board authorization. Council stated though they appreciate the efforts of Hobson, they have also been advised by legal counsel that the Council can require the CCAB to follow policies and procedures set by the Council in regards to salaries. Commissioner Chairman Brian Haupert stated it would be in the best interest of all parties if Ridenour would meet with County Attorney Downs to review all statues set forth at this meeting. Ridenour stated he would contact Attorney Downs this week. Council will take request under advisement.

## NOTE:

• Ridenour requested Auditor Jane Ridgeway present a total of all additional appropriations from July 1, 2009 to present.

Kaltenmark made a motion to adjourn the October 26, 2009 meeting; his motion was seconded by Evans and passed with a 7-0 vote.
