### MARCH 22, 2010

Wabash County Council met in regular session on Monday, March 22, 2010 at the Wabash County Courthouse. Prayer was offered by Jim Kaltenmark. Chairman Mike Ridenour called the meeting to order at 5:00 P.M. with all members present: Mike Ridenour, James Kaltenmark, Gary Nose, Ted Little, Daryl Evans, Randy Curless and Claude Markstahler. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the minutes of the February 22, 2010 meeting. Curless made a motion to approve the minutes as written; his motion was seconded by Little and passed by a 6-0 vote. Markstahler was not present at the February  $22^{nd}$  meeting.

Next the Council heard recommendations for the County Tax Abatement Committee presented by Bill Konyha, Executive Director and CEO of Wabash County Economic Development Group (EDG). Konyha stated the Novae Corporation, who recently purchased the former Dexter Axle property in North Manchester will be requesting a tax abatement in the near future. Konyha recommended the County Council create a Tax Abatement Committee to address this request and to have a plan in place for any future business interests. Konyha stated the City of Wabash has a Committee and steps in place that the county could parallel. The city deals with commercial, industrial and residential tax abatements. The residential is separate and would not be a part of this process for the county. Konyha stated "agricultural" would also be considered if there is a capital investment and jobs are created. The Committee would consist of two (2) Councilmen, one (1) Commissioner, County Attorney, Auditor, Planning Director, Chamber of Commerce President, and President of EDG as Chair. Konyha stated the Committee reviews the form submitted by the applicant (an SB1 - Statement of Benefits), an interview would be conducted, the committee would vote on eligibility, according to a pre-set point system and the Committee's recommendation would be presented to the Council. Konyha recommended Council adopt a resolution that would establish a Tax Abatement Committee. Curless made a motion to create a Tax Abatement Committee for commercial, industrial, and agricultural tax abatements; his motion was seconded by Evans and passed by a 7-0 vote. Council unanimously approved Ridenour and Curless as Council representatives on the Committee. Commissioners Barry Eppley and Brian Haupert unanimously appointed Commissioner Scott Givens as the Commissioners' representative on the Committee. The Committee will also include Auditor Jane Ridgeway, County Attorney Steve Downs, Planning Director Mike Howard, Chamber of Commerce President Kim Pinkerton and Konyha as Chair. Ridenour requested a resolution be presented at the next Council meeting, April 26th.

Council was asked to appoint a member to the Region III-A Board of Directors. Ridenour expressed interest in serving on the board. Curless made a motion to appoint Ridenour as the 2010 Council Representative on the Region III-A Board; his motion was seconded by Little and passed by a 6-0 vote.

The next order of business was to discuss the City-County Ambulance Agreement. Auditor Ridgeway presented the agreement that furnishes Wabash County with ambulance and rescue service. This agreement will run from 2010-2012 at the same 2% annual increase as the previous agreement: \$159,180 in 2010, \$162,360 in 2011 and \$165,600 in 2012. The agreement was approved by the Wabash City Board of Works on Wednesday, March 17<sup>th</sup> and approved by the Wabash County Board of Commissioners at their meeting today, March 22<sup>nd</sup>. Council requested a quarterly report at their next meeting. Ridgeway stated she would present the report. Kaltenmark made a motion to approve the City-County Ambulance agreement as presented; his motion was seconded by Evans and passed by a 7-0 vote.

The council then addressed Additional Appropriation requests as advertised:

To fund the recommended Wabash County contributions to the Wabash County Police Pension Fund, per the McCready and Keene, Inc. Actuarial Report. This appropriation is to be used if/when Civil Process Collections from the Clerk and the Sheriff, as well as Sheriff's Sales receipts, are inadequate.

Auditor Ridgeway stated the recommended contribution amount for the 2009 Pension Fund was \$102,000 but, there was a \$35,000 shortfall. Ridenour stated the \$43,500 request is for the 2009 contribution shortfall and the actuarial and bank fees. Ridgeway stated the actuarial fees were \$3,000 in 2006 and \$8,300 in 2009. The bank fees have remained approximately \$6,000. Little stated he had contacted Elaine Beaty of McCready and Keene, Inc regarding the fact that the Pension Fund was said to be self funded but is not, as well as other questions on the Pension Fund. Little stated Beaty agreed to come to the April 26th Wabash County Council meeting to answer any questions that the Council may have on this subject. Little stated if any members have questions, he would be happy to send them to her for prior consideration. Striker stated that the Pension Fund technically has never been fully funded. It is only fully funded as far as there are sufficient funds collected

from the civil process and the Sheriff Sale fees. Striker stated the Sheriff's Sale fees are now deposited into the Pension Fund. The

amount will be noted in the report following the next Sheriff's Sale. Kaltenmark made a motion to approve the 2009 Sheriff's Pension Fund contribution shortfall totaling \$43,500; his motion was seconded by Evans and passed by a 4-3 vote. (Nose, Markstahler, and Little opposed). Commissioner Barry Eppley stated that the 2010 recommended contribution appropriation request had been \$150,000 but the Commissioners lowered the amount to \$60,000 and would ask to appropriate more funds as needed. Nose made a motion to table the 2010 Sheriff's Pension Fund contribution until after the discussion with Beaty at the April 26th meeting; his motion was seconded by Kaltenmark and passed by a 7-0 vote. Nose and Little extended an invitation to the Merit Board members to attend the April 26th Council Meeting also. Council asked who was on the Merit Board and how they are appointed. Striker stated there are five (5) members on the board for a four (4) year term; three (3) are chosen by the Sheriff and two (2) are chosen by the deputies. Three (3) are registered republicans and two (2) are registered democrats. The current members are Bob Fuller, Christina Lynn, Michael Brane, Terri Weaver, and Dr. Dean Gifford.
