Wabash County Council met in regular session on Monday, October 24, 2011 in the Commissioners' Meeting Room at the Wabash County Courthouse. Claude Markstahler offered with a word of prayer. James Kaltenmark led in the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with all members present: Kaltenmark, Randy Curless, Gary Nose, Jeff Dawes, Ted Little, Markstahler and Daryl Evans. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the 2012 Budget Hearings and meeting minutes of September 12, 2011. Curless made a motion to approve as presented; his motion was seconded by Dawes and passed by a 6-0 vote. (Markstahler was not present on September 12th.)

Steve Downs, County Attorney, presented the Wabash County Police Retirement Fund IRS Restatement. Downs stated there are sixteen (16) changes to the plan; six (6) are in regard to technical requirements regarding the IRS and ten (10) are Indiana state law changes. Downs stated the effective date is January 1, 2010. Downs stated on the recommendation of McCready & Keene, Incorporated the document as presented is acceptable. After much discussion, Nose made a motion to approve all recommended changes to Wabash County Police Retirement Plan; his motion was seconded by Evans and passed by a 7-0 vote.

Steve Johnson, Director of Solid Waste Management, presented a monthly report:

- 1. Visitor numbers increased 38.1% over 2010
- 2. 18,477 pounds of electronics were shipped in September
- 3. Drop-off recycling is slightly lower than last year
- 4. The Municipal Cost Index has increased 8% A national number according to the Bureau of Labor Statistics -thus the service fee per ton will increase from \$103.26 to \$111.93.
- 5. Amendment to Resolution 2011-6 was passed on October 11, 2011. Special assessment language was changed. It clarified that no agricultural parcels are to be included. It also restates that parcels classified as "residential", but not classified as a "homestead" or "qualified residential" parcel, must have an assessed value of \$10,000 or greater in order to be assessed a solid waste fee.

Kaltenmark opened the floor for public comments regarding agenda items. James Wolfe from Boy Scout Troop 429 was present to attend the public meeting.

The next order of business was to address the Additional Appropriation requests as advertised:

Little made a motion to approve request; his motion was seconded by Nose and passed by a 7-0 vote. Sheriff Bob Land stated the Commissioners approved a part-time civil process position at the jail. This will be paid from Commissary Funds. Currently the Commissary Clerk's salary is paid from the Commissary Funds and the Social Security is paid by the County. Land requested this new position be set-up the same way. This position will require 4 to 8 hours per week and will help free up time for the deputies. The employee is certified by the Reserves. The pay will be paid at an hourly rate; approximately \$16. Little made a motion to approve the part-time position; his motion was seconded by Evans. Nose asked if this position needs to be advertised. County Coordinator Jim Dils stated we currently have a pool of applicants for positions at the jail that was collected in the last few months and it is appropriate to utilize this pool. The motion passed by a 7-0 vote.

Little asked about proposed changes by the State which could require the county jail to house individuals convicted of a Class D felony. This would dramatically change funding needs for the jail; an increase of approximately 44 inmates. Little and Nose stated the Council or Commissioners need to address this issue by contacting state legislators. Land stated the current understanding is that no funds would be given to counties to cover the additional costs. Little requested that the Commissioners draft a letter with County Attorney Steve Downs notifying the State that we do not want this change without adequate funding. Commissioner Barry Eppley agreed to work with Downs to draft such a letter.

This Officer would respectfully request that this Council approve the transfer of \$5,000 from Adult Probation User Fee. The server, located in the Wabash County Clerk's Office, is in grave need of replacement. All offices located within the Judicial Building use the server and an agreement has been made that the Clerk's Office will pay \$2,000 form their IV-D Fund, the Prosecutor will pay \$3,000 from his IV-D Fund, each court will pay \$1,000 and the probation Department will pay \$3,000 from probation user fees. However, the court does not have any excess money; thus, this Officer is requesting that Adult Probation User Fees be used to fund the remaining \$5,000 needed to purchase the new server.

Elaine Martin, Clerk, requesting for Dallas Duggan, stated the total cost is \$9,789. Martin stated the server was down three (3) separate times and action was taken prior to the server crashing. Martin stated the data is currently being transferred from the old to the new server. Little made a motion to approve request; his motion was seconded by Curless and passed by a 7-0 vote.
