Wabash County Council met in regular session on Monday, December 5, 2011 in the Commissioners' Meeting Room at the Wabash County Courthouse. Claude Markstahler offered a word of prayer. James Kaltenmark led the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with six members present: Kaltenmark, Gary Nose, Jeff Dawes, Ted Little, Markstahler and Daryl Evans. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the minutes of the October 24, 2011 meeting. Little made a motion to approve the minutes as presented: his motion was seconded by Nose and passed by a 6-0 vote.

Kaltenmark mentioned a press release supplied by Wabash County Prosecuting Attorney Bill Hartley which stated that as of January 1, 2012 his office will employ Brian Michaud as a Full-Time Chief Deputy Prosecuting Attorney. This position will be funded by the State of Indiana as was the former Part-Time Deputy Prosecutor position which will now be eliminated.

Kaltenmark opened the floor for public comments regarding agenda items. Jim Goodpasture, of rural LaFontaine, commented on recent newspaper articles concerning the removal of test wells located in the proposed Lafontaine TIF area. Goodpasture noted there are seven (7) wells not five (5) at this location. Kaltenmark thanked Goodpasture for attending and stated he would like to discuss this further based on where it appears on the agenda (as an additional appropriation request for funding by the Wabash County Commissioners).

The next order of business was to address the Additional Appropriation requests as advertised:

Wabash County Sheriff Bob Land stated these are funds received from Community Corrections Grant Funds by the Sheriff's Department for assistance with the cost of the yearly utilities which were placed in the County General Fund. This request is to appropriate the additional funds received. Little made a motion to approve the request as presented; his motion was seconded by Dawes and passed by a 6-0 vote.

Land stated the Indiana Law Enforcement Academy notified all law enforcement departments in Indiana that due to budget cuts they will only be scheduling three (3) classes in 2012. Land stated he would like to set a hire date of January 1, 2012 and enroll the approved new hire Scott Campbell in the class beginning January 3, 2012. Land stated if they wait to enroll at a later date, it could delay the training by up to nine (9) months. Council unanimously approved the Sheriff's requests.

Land said he has had no further report on the Class D Felony letter discussed by the Council in October. County Coordinator Jim Dils stated County Attorney Steve Downs has drafted a letter and it will be available to be signed at the meeting on January 3, 2012.

Land requested guidance on the leasing of three (3) vehicles for his fleet. Land stated he could save \$1,400 per vehicle if he can proceed before year end and intends to purchase a used 4-wheel vehicle with the remaining funds. Council stated they had approved this in the 2012 Budget and Ridgeway said the DLGF Field Representative has informed her that the County General Fund should have no changes and could be approved by December 25th. Council gave unanimous consent for Land to move forward on the vehicle request.
