Wabash County Council met in regular session on Monday, June 25, 2012 in the Commissioners' meeting room of the Wabash County Courthouse. Claude Markstahler opened with a word of prayer. James Kaltenmark led in the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with all members present: Kaltenmark, Markstahler, Randy Curless, Gary Nose, Jeff Dawes, Ted Little and Daryl Evans. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the minutes of the May 29, 2012 meeting. Markstahler made a motion to approve the minutes as written; his motion was seconded by Curless and passed by a 7-0 vote.

Jenice Rankin, Executive Director of the Wabash County Solid Waste Management District:

- 1. Presented a report from controller Ken Ahlfeld. Ahlfeld stated the SWMD is a different type of entity. All other county government departments receive a tax levy which provides a guaranteed income. The SWMD does not receive a tax levy, does not collect taxes and is not guaranteed any income. The main revenue is from tipping fees which fluctuate. Since the SWMD is a state mandated entity, setting funds aside is a necessary action. Ahlfeld stated the \$24/\$12 user fee has not increased the cash balance. It was the same in 2009 as in 2011. The user fee is used specifically to cover the cost of the drop-off recycling program and for administrative fees in regard to this drop-off program. Rankin stated it is important that the county presents a positive picture of the services provided by the SWMD. Rankin stated the complaints were numerous in 2011 but there have only been three (3) in 2012.
- 2. Presented the May 2012 monthly financial report
- 3. Stated after meeting with the SWMD board, a \$70,000 payment was made toward the principal on the loan. Little stated he is glad to see this prudent plan of action and feels the SWMD is moving in the right direction.

Jeff Hobson, Community Corrections Director presented a report on the 2012-2013 Grant Budget and the Council was provided detailed budget forms.

1. Hobson stated there were no changes to the grant except to arrange funds for salaries so only 50% is paid by Department of Corrections – this allows the program to serve misdemeanants; the other portion is paid from Project Income Fund #0046. The total grant amount is the same as last year and begins July 1, 2012. Hobson stated no raises are included.

- 2. Hobson discussed different aspects of Community Corrections programs:
 - a. 22 on home detention; 6 on work release; 10 in adult day reporting and 3 in community transition program.
 - b. Several individuals have had to serve their jail time due to the weak economy.
 - c. It is a difficult task assisting convicted felons to find a job. There is a great deal of competition. However, there have been several companies in the area who have worked with them.
 - d. The Day Reporting Program works a great deal with those who are behind on child support. It has been a great program to help these individuals find employment to pay their debt.
 - e. They currently have a part-time employee who has substance abuse education and have been working with Judge Goff to assist with substance abuse convictions. There is an AA meeting for the women at the jail every Saturday morning.
- 3. Ridgeway stated the council's 2012 Salary Ordinance will need to be amended to include the Community Corrections 2012-2013 salaries for the remainder of the calendar year. Nose made a motion to amend the Salary Ordinance; his motion was seconded by Little and passed by a 7-0 vote.
- 4. Council extended their appreciation to Hobson for all his hard work and services which Community Corrections provides to Wabash County.

Cheri Slee, Wabash County Surveyor, stated she has an additional appropriation request totaling \$8,000 submitted for the July 23rd meeting but requested permission to move forward with an extended contract for GIS measurement to more accurately reference public land corners. Slee stated they have done Chester and would like to have funding to move forward with Noble and Waltz Townships. Council gave consensus to move forward.

Kaltenmark opened the floor for public comments regarding agenda items. No comments were offered.

The next order of business was to address the Additional Appropriation requests as advertised:

Mr. Norman Hanford has worked for the Health Department as Environmental Food Inspector since May 23, 2007. He was paid by contract services at \$13.00 per hour. In 2011, Mr. Hanford worked 418.25 hours at \$13.00 per hour which was a total of \$5,437.25. In 2010, he worked 398.5 hours at \$13.00 per hour for a total of \$5,180.50. On January 1, 2012, Hanford was started as a part-time employee for the county; his pay being \$11.00 per hour with \$2,500 as the budget for the year. On April 24, 2012, the Wabash County Health Department met and a notion was made to allow Hanford to work 8 hours a week at \$14.00 per hour with pay retroactive back to January 1, 2012, all voted with a unanimous vote. This would have him working 416 hours in 2012 at \$14.00 per hour. The current budget is \$2,500. The Council passed the current appropriation of \$5,824; this would be an additional appropriation request of \$3,324.

Kathryn Carter-Lower, Health Office Manager and Dr. Jeffrey Pyle, Health Board President, stated Norman Hanford's services are utilized a great deal during the summer. Hanford stated he cannot continue to provide his services for \$11.00 per hour. Dr. Pyle stated he contacted 12 other counties and the range was from \$9 to \$19 with an average of \$13.70 per hour. Little stated this was one area of the Health budget requests that was cut last year by the Council in order to confirm with the overall funding available. Based on funds now available, Little made a motion to approve the request. Dawes asked if they had discussed cutting back the amount of hours to fit into the budget. Dr. Pyle stated the hours are very consistent each year. Carter-Lower stated the hours include weekdays, weeknights and weekends at festivals. Dr. Pyle stated we are in the middle or higher range with other counties with efficiency for manpower to hours required. Carter-Lower stated they would like this to be retroactive to January 1, 2012. Nose stated he does not want to make this retroactive. Little rescinded his motion and made a motion to approve this request to \$14 per hour effective June 24,

This was presented to the Wabash County Council, read in full, and adopted on the 25^{th} day June 2012, by the above aye and nay vote.

Per IC 36-8-16-7, as of July 1, 2012, the E-911Landline Fund #0054 and E-911 Wireless Fund #0177 are to be combined to create the new Statewide 9-1-1 Fund #1222. Evans made a motion to approve; his motion was seconded by Dawes and passed by a 7-0 vote.

Bob Brown, EMA and Central Dispatch Director stated:

- 1. The new monthly fee for all cell and landline phones will be \$.90.
- 2. The State's "hold harmless" calculation for Wabash County will be \$473,960 for both wireless and landline. Wabash County is guaranteed to receive this amount for the next three (3) years; this amount was based on the average of 2008, 2009 and 2010. Any additional funds will depend on the county's percentage.
- 3. Pre-paid cell phones are now \$.50 per call.
- 4. Brown stated this simplifies the collection process in that all funds will go to the State and then a check will be sent to each county. Brown stated there is no change in how the money may be spent.
- 5. Markstahler extended his appreciation to Brown for having the radio program up-to-date. Brown stated we are where we need to be because the state's system is not working as well as the FCC had anticipated.
- 6. The Indiana Public Safety Committee has added two (2) more frequencies with five (5) now on both Wabash County towers.

Curless gave a report on the County Tax Abatement Committee which recently met with Bill Konyha, President and CEO of Wabash County EDG. He stated for a property to qualify for residential tax abatement:

- Needs to be in a Council designated "Economic Revitalization Area".
- The area can be no more than 10% of total area within the designating body's jurisdiction.
- Tax deduction is allowed for not more than a 5 year period.

Curless stated the committee felt that this would:

- Limit the benefits to a very few residents.
- Only benefit targeted areas which are a small percentage of the county.
- The economic savings of the abatement for homeowners over 5 years would not likely encourage a decision to buy or build in the area.
- Questionable return on investment value for the county and to taxpaying residents.

In conclusion, Curless stated the committee recommends not proceeding with a county tax abatement program but does recommend continuing to work with Konyha to evaluate other methods of growth and residential living in Wabash County. Kaltenmark stated he would like to set a Special Meeting on Thursday, September 6, 2012 at 5:00 P.M. for the 2013 Civil Budget Non-binding Reviews. Ridgeway stated due to legislative changes this year the Wabash City Schools' budget will be a Binding Review (due to the fact that they have an appointed rather than elected board) in addition to the Wabash County Solid Waste Management District's 2013 Budget which must be approved by the County Council following a Binding Review as well.

Kaltenmark opened the floor for public comments on non-agenda items. No comments were offered.
