SEPTEMBER 10, 2012

WABASH COUNTY COUNCIL AND WABASH COUNTY BOARD OF COMMISSIONERS JOINT SPECIAL SESSION

Wabash County Council met in Joint Special Session on Monday, September 10, 2012 at 3:00 P.M. in the Commissioners' Meeting Room of the Wabash County Courthouse. Council Members: James Kaltenmark, Claude Markstahler, Randy Curless, Gary Nose, Ted Little, Jeff Dawes and Daryl Evans met with Wabash County Commissioners Brian Haupert, Barry Eppley and Scott Givens for discussion with representatives from the Wabash County Hospital. Also present was Wabash County Auditor Jane Ridgeway.

Hospital officials discussed possible future expansion plans for the hospital with the county officials and updated the Council concerning possible financing options if the project should move forward. No decision or action was taken as this was only a preliminary discussion.

Markstahler made a motion to adjourn the Joint Special Session; his motion passed by a 7-0 vote.

WABASH COUNTY COUNCIL SPECIAL SESSION AND 2013 BUDGET ADOPTION HEARING FOR WABASH COUNTY SOLID WASTE MANAGEMENT DISTRICT

Wabash County Council met in Special Session on Monday September 10, 2012 at 4:30 P.M. in the Commissioners' Meeting Room of the Wabash County Courthouse. Council Members: James Kaltenmark, Claude Markstahler, Randy Curless, Gary Nose, Ted Little, Jeff Dawes, and Daryl Evans, along with Wabash County Auditor Jane Ridgeway and Wabash County Solid Waste Management District Controller Ken Ahlfeld met to hold the 2013 WCSWMD Budget Adoption Hearing. Also present were Commissioners: Brian Haupert, Scott Givens and Barry Eppley. Following review, Evans made a motion to approve the WCSWMD 2013 Budget as presented at the Binding Review and First Budget Hearing on August 16th; his motion was seconded by Curless and passed by a 7-0 vote.

Little made a motion to adjourn the Special Session WCSWMD Budget Adoption Hearing; his motion passed by a 7-0 vote.

REGULAR SESSION AND ADOPTION HEARING FOR WABASH COUNTY 2013 BUDGETS

Wabash County Council met in regular session on Monday, September 10, 2012 in the Commissioners' Meeting Room of the Wabash County Courthouse. Claude Markstahler opened with a word of prayer. James Kaltenmark led in the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with all members present: Kaltenmark, Randy Curless, Gary Nose, Ted Little, Jeff Dawes, Markstahler and Daryl Evans. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

The first order of business was to review the minutes of the Departmental Budget Hearings and the regular Council meeting held on August 14, 15 and 16, 2012. Nose made a motion to approve the minutes for the meetings as written; his motion was seconded by Curless and passed by a 7-0 vote.

The next order of business was to review the minutes of the Non-Binding Review of Wabash County Civil Taxing Units 2013 Budgets held on September 6, 2012. Council members present unanimously confirmed their recommendations for the units' 2013 Budgets as follows:

- 1. Each 2013 budget should not exceed the 2.8% growth quotient.
- 2. The DLGF may cut the presented 2013 budgets if they exceed maximum levy allowed.
- 3. Council recognizes the uniqueness of each situation/request. The ultimate decision is made by the DLGF.

Nose made a motion to approve the Non-Binding Review minutes as presented; his motion was seconded by Dawes and passed by a 6-0 vote (Little abstained as he was not present for the September 6th reviews).

The next order of business was to address the second advertised Hearing for Adoption of the Wabash County 2013 Budgets. Kaltenmark led a discussion of several specific items for clarification within the General Fund Budget as follows:

- 1. Both the Superior and Circuit Court Judges requested additional part-time assistance for \$7,500 in each of their budgets. Council gave unanimous consent.
- 2. Veterans' Service Officer Cameron Lochner requested his salary be lowered to \$12,000 and the remainder, approximately \$500, be placed in the Capital Outlay appropriation. Nose made a motion to approve request; his motion was seconded by Little and passed by a 7-0 vote.
- 3. Sheriff's Merit Deputy Pay: Curless made a motion to approve (Option 2) of the proposals presented by Sheriff Land; his motion was seconded by Evans and passed by a 7-0 vote.

Council reviewed the revised 2013 Budget Form 4-Bs: Budget Estimate-Financial Statement-Proposed Tax Rates, (formerly known as the "sixteen-line statement"). The Council-Approved budget columns have been updated and re-calculated following the cuts made by the Council in August. Ridgeway stated she used the new 2012 pay 2013 Net Assessed Values recently received from the Assessor (these were not available at the time of the original budget form preparations). Ridgeway noted the estimate of possible Additional Appropriations for the remainder of 2012 on the General Fund Budget Form 4B was increased from \$59,000 to \$259,000 as discussed during the budget hearings.

Following the second reading of the 2013 Wabash County Budget totaling \$7,633,123, (this included cuts totaling \$71,293 from the General Fund and appropriating \$1,579,402 in the new Wabash County Certified CAGIT Budget); Little made a motion to approve the 2013 General Fund Budget and all subsequent Wabash County Special Revenue Fund Budgets; his motion was seconded by Evans and passed by a 7-0 vote. This included a 1% across-the-board wage increase for most Wabash County employees as well as the remainder of the final step of salary increases based on the Job Study Analysis as originally recommended by the Personnel Administration Committee in 2011.
