DECEMBER 3, 2012

Wabash County Council met in regular session on Monday, December 3, 2012 in the Commissioners' meeting room of the Wabash County Courthouse. Gary Nose offered a word of prayer. James Kaltenmark led in the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with six members present: Kaltenmark, Nose, Randy Curless, Ted Little, Jeff Dawes and Daryl Evans. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway.

Kaltenmark recognized Jane Ridgeway for her eight (8) years of service as Wabash County Auditor and Council Secretary. Kaltenmark then recognized and presented a plaque to Daryl Evans for his four (4) years of service. Kaltenmark also recognized and presented a plaque to Ted Little for his seven (7) terms as Councilman: 28 years of service.

The first order of business was to review the minutes of the October 22, 2012 meeting. Curless made a motion to approve the minutes as written; his motion was seconded by Dawes and passed by a 6-0 vote.

Kaltenmark opened the floor for public comments regarding agenda items. No comments were offered.

The Original Wabash County Comprehensive Plan (then called the Master Plan) was written in 1965 and was obviously outdated, having only been altered with a few amendments in the past 47 years. Using IC 36-7-4 as a guideline, the Planning Commission began interviewing firms in March 2010 for the development of a new Comprehensive Plan. Ground Rules (Bradley Johnson, President) and P.B. World & LSL Planning Assoc. were interviewed with projected quotes from \$35,000 to \$75,000, depending on the age and complexity of the proposed ordinance. After serious consideration of the alternative and projected costs, Mike Howard felt much of the work in development of the Plan could be completed "in house," with dramatic savings to the county. To date, \$11,898 has been appropriated for the development of the Comprehensive Plan; with

only \$2,911.73 spent as of October 15, 2012. The WCPC is requesting \$5,000 to be paid to Mike Howard as compensation for contractual development of the Comprehensive Plan. Since the beginning of the project which was over a two and a half (2 ½) years, Howard has worked 2,215 hours on the Plan, with 763 hours over and above available compensation time. Within his position as Planning Commissioner Director, Howard has coordinated the development of the CAFO ordinance and the Wind Energy ordinances with no additional compensation; as they were deemed as part of his job responsibilities. However, the Planning Commission views the creation of the Master Plan as a separate project, which Howard has taken upon himself at a savings of \$25,000 to \$65,000 for the residents of Wabash County.

After much discussion regarding extra compensation for Howard (a salaried-exempt employee) Little made a motion to approve request; no second was offered. The motion died for lack of a second. Council stated this would set a precedent that they do not want to establish, as other employees also work over and above regular hours and duties. Curless stated Howard did an amazing job on the project and does deserve recognition but not in this manner.

Howard stated that Councilman Little has served on the Plan Commission Board for the past twelve (12) years. With Little's retirement, a new County Council representative will be needed. Howard stated the PCB would like to recommend Randy Curless for this position. Dawes made a motion to appoint Curless as the PCB Council representative; his motion was seconded by Nose and passed by a 5-0 vote.
