ADOPTION HEARING FOR WABASH COUNTY 2014 BUDGETS AND REGULAR COUNCIL MEETING

The Wabash County Council met in special session on Monday, September 9, 2012 in the Commissioners' Meeting Room of the Wabash County Courthouse. Claude Markstahler opened with a word of prayer. James Kaltenmark led in the Pledge of Allegiance. Kaltenmark called the meeting to order at 5:00 P.M. with all members present: Kaltenmark, Randy Curless, Gary Nose, Jeff Dawes, Claude Markstahler, Bill Ruppel and Mike Ridenour. The proceedings of the meeting were recorded by Wabash County Auditor Linda Conrad.

The first order of business was to review the minutes of the Departmental Budget Hearings and the regular Council meeting held on August 20, 21, and 22, 2013. Ruppel made a motion to approve the minutes for the meetings as written. Curless seconded the motion; it passed by a 7/0 vote.

Deborah Gregg, Clerk-Treasurer of the Town of LaFontaine and Kristie Bone, Clerk-Treasurer of the Town of Lagro presented their 2014 proposed budgets to Council as part of the non-binding review process since they could not be present at the Non-Binding Review hearing previously scheduled on September 5, 2013.

FINAL REVIEW AND ADOPTION HEARING FOR 2014 BUDGETS

The next order of business was to address the second advertised Hearing for Adoption of the Wabash County 2014 Budgets. Kaltenmark led a discussion of several specific items for clarification within the General Fund Budget as follows:

- 1. Council members asked specific questions of the County Commissioners regarding the use of monies designated in the CEDIT Fund's three-year capital improvement projects plan and the Highway Improvement Project within the CAGIT-Certified Shares Fund. Council agreed that this line item should no longer be necessary due to the increased funding to be received by the Highway Department in 2014 and should instead be helping to fund some of the line items in the Commissioners Dept. budget within the General Fund. Council also agreed that Riverboat-County Share Fund should be used to fund General Fund expenses whenever possible since both the CAGIT and Riverboat revenues were formerly deposited into the General Fund but now are deposited separately into their own funds.
- 2. The Circuit and Superior Court Judges requested one additional employee to serve both courts at a cost of \$30,568; \$15,284 in both departmental budgets. Council gave unanimous consent.
- 3. The County Sheriff requested two additional jail officers at a cost of \$67,698 and the Council gave unanimous consent for one additional jail officer at a cost of \$33,849 and increased the overtime and part-time jail officers line items.
- 4. The Chief Probation officer requested one additional juvenile probation officer at a cost of 30,839. Council gave unanimous consent.

- 5. The County Extension Director requested a full-time administrative assistant at a cost of \$24,000 with no funding in 2014 for a part-time secretarial position. Council unanimously denied the full-time employee request, but approved the funding for the part-time secretarial position.
- 6. The line items of Care of Wards in Institutions in the amount of \$400,000 and the Animal Shelter allocation of \$90,000 within the Commissioners departmental budget of the General Fund will be funded from the CAGIT-Certified Shares Fund in addition to the already proposed budgeted line items. The line item of computer software maintenance & training payment of \$32,918 within the Auditor's departmental budget of the General Fund will be funded from the CAGIT-Certified Shares Fund.
- 7. The Education & Training line item within the Sheriff Department and the Record Scanning line item within the Jail Department of the General Fund will be funded from the Sheriff's Misdemeanant Fund.
- 8. The Jail Inmate Transfers line item in the Jail Department of the General Fund will be funded by the Riverboat-County Share Fund.
- 9. Probation Department's partial amounts of some line items within the General Fund will be funded by the Adult Probation Users Fees Fund.
- 10. The County Coroner's departmental budget will remain the same as the 2013 budget because the 2014 proposed budget was not submitted on time for the budget hearings.
- 11. The Central Dispatch department's increases in overtime and part-time dispatchers' line items in the General Fund will be funded from the Statewide 911 Fund.
- 12. CASA Program local match amount (as required to qualify for grant funding) will be funded by the Rainy Day Fund.
- 13. The 2014 budgets include a 2% salary increase (with a few exceptions) subject to the Salary Committee's pending recommendation and Council's pending approval of the 2014 Salary Ordinance.

Chief Deputy Auditor Grube reviewed the <u>Budget Form 4</u>, the <u>Ordinance for</u> <u>Appropriations and Tax Rate</u> with Council which included the revised 2014 DLGF-reviewed funds and home-ruled funds, the Adopted Budget column, the Adopted Tax Levy column, and the Adopted Tax Rate column that had been updated and re-calculated following the cuts made by the Council and using the new 2013 pay 2014 Net Assessed Values that have been certified to the State. See the approved ordinance below:

ORDINANCE OR RESOLUTION FOR APPROPRIATIONS AND TAX RATE

Be it ordained by the **Wabash County Council** that for the expenses of **WABASH COUNTY** for the year ending December 31,2014 the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expense of **WABASH COUNTY**, the property tax levies and property

tax rates as herein specified are included herein. Budget Form 4-B for all funds must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

During the scheduled budget hearings and after the second reading of the 2014 Wabash County General Fund proposed budget totaling \$8,039,237 had been reduced to \$7,283,245, after making cuts of \$136,074 from the General Fund and adjustments of \$522,918 to be appropriated from the CAGIT-Certified Shares budget, \$50,000 to be appropriated from the Riverboat-County Share Fund, \$7,000 to be appropriated from the Misdemeanant Fund, and \$40,000 to be appropriated from the Rainy Day Fund; Ridenour made a motion to approve Ordinance #2013-85-08 approving the 2014 General Fund Budget and all subsequent Wabash County Special Revenue (home-ruled) Fund budgets. Ruppel seconded the motion and it passed by a 6-1 vote with Council member Nose as the only nay vote. See the approved budget below:
