#### WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, October 28, 2013 in the Commissioner's Meeting Room of the Wabash County Courthouse. #### WABASH COUNTY 2014 SALARY ORDINANCE

The ordinance includes a 2% salary increase for elected officials and full-time county employees across the board with the exception of the County Coroner's salary. Ridenour made a motion to approve the 2014 Salary Ordinance as submitted. Ruppel seconded the motion; it passed by a 7-0 vote.
