WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, December 1, 2014 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman James Kaltenmark called the meeting to order at 5:00 P.M. with seven members present: Kaltenmark, Claude Markstahler, Randy Curless, Gary Nose, Jeff Dawes, Bill Ruppel and Mike Ridenour. Markstahler opened with a word of prayer and Kaltenmark led in the pledge of allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

The next order of business was to review the minutes of the October 2014 meeting. Ruppel made a motion to approve the minutes. Dawes seconded the motion and it passed by a vote of 7-0.

Kaltenmark asked for comments about agenda items. There were no comments from the public.

The next order of business was the convening of a public hearing for the consideration of tax abatement for Vision Properties, LLP and Midwest Eye Consultants, PC. Bill Konyha, Economic Development Group of Wabash County Executive Director explained that the Tax Abatement Committee has not met vet, so he requested that this matter be tabled until the next Council meeting. He explained the statistics of the tax abatement request including the impact of local payroll taxes and the total of property and income taxes to be generated. Kim Pinkerton, Chamber of Commerce member spoke in support of the requested abatements. Council members questioned the per capital county income. Dawes asked about the companies' accountability to comply with the statement of benefits listed on their applications for tax abatement. Konyha explained that each year the companies must submit a form of compliance to Council. Konyha explained that he will be leaving the Wabash Economic Development Group and has recommended a replacement for his position. Konyha updated the Council on the current and future Wabash County economic development projects. Ruppel and Kaltenmark thanked Konyha for his service to Wabash County. Ruppel made a motion to table the abatement resolution until the January 2015 meeting. Ridenour seconded the motion; it passed by a 7-0 vote.

The next order of business was to address the Additional Appropriation request:
