WABASH COUNTY COUNCIL MEETING & FINAL ADOPTION HEARING OF THE 2017 BUDGETS

The Wabash County Council met in session on Monday, September 26, 2016 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Mike Ridenour called the meeting to order at 5:00 P.M. Seven Council members were present: Ridenour, Randy Curless, Claude Markstahler, William Ruppel, Matt Dillon, Jeff Dawes, and Kyle Bowman. Markstahler opened with a word of prayer and Ridenour led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Ridenour requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the Sept. 6, 7, 8, and Sept. 12th 2017 budget hearings. Dillon made a motion to approve the minutes. Ruppel seconded the motion and it passed by a 5-0 vote. Ridenour and Markstahler abstained since Ridenour was tardy and Markstahler was absent for the Sept. 12, 2016 budget hearing.

The next order of business was to address the Additional Appropriation requests. Present for the requests were: EMA Director Keith Walters, Veteran's Service Officer Sam Daughtery and Sheriff Robert Land.

Dillon made a motion to approve the request for an additional appropriation. Markstahler seconded the motion and it passed by a 7-0 vote.

Presented to the Wabash County Council, read in full and adopted this 26th day of September, 2016 by the above aye and nay vote. The Auditor was directed to present the above additional appropriation to the Department of Local Government Finance for approval as provided by law.

Council briefly discussed the "Exemption Adjustments and 2017 Proposed Salaries" email memo sent to Council from Human Resources Director, Jim Dils concerning currently exempt Wabash County government positions. Dils was present and explained that the minimum salary of certain currently exempt positions paying less than \$47,476 will be required to both raise the

salary to the new minimum threshold and continue to classify the position as exempt <u>or</u> reclassify the position as non-exempt, so the employee becomes eligible for compensation time or overtime pay. Dils stated that the deadline for compliance is December 1, 2016. Ruppel stated his concern about how overtime would be calculated if the Council decided to change some exempt positions to non-exempt. Council members stated that they would be interested in the least costly solution that would keep County government in compliance. Dils stated that several county conferences and county groups will be addressing this in the near future. Ridenour suggested that the Wabash County Salary & Wage Personnel Committee meet soon to review the options and then make a recommendation to Council.

FINAL ADOPTION HEARING OF THE 2017 WABASH COUNTY BUDGETS

Councilman Dawes thanked the County departments for their cooperation and the County Auditor's office for the assistance that Council received during the 2017 budget process. Council's consensus was to approve the budgets as previously modified at the Sept. 12th budget hearing with salary increases as designated, decreases to the proposed budgets as designated, and the transfer of certain expenses as designated. Upon approval by Council, the estimated property tax levy will be approximately \$10,350 over the maximum levy allowed. The maximum levy will be officially determined by the Department of Local Government Finance (DLGF) after submission of the budgets and tax levies by the Auditor's office.

Ruppel made a motion to approve **Ordinance #2016-85-07** for **2017 Appropriations and Tax Rates which adopts the General Fund Budget, the Tax-rated Fund Budgets and all Wabash County Special Revenue (home-ruled) Budgets.** Curless seconded the motion and it passed by a 6-1 vote with Mike Ridenour voting against approval.
