WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, June 26, 2017 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Jeff Dawes called the meeting to order at 5:00 P.M. Seven Council members were present: Dawes, Randy Curless, Matt Dillon, Kyle Bowman, Lorissa Sweet, Philip Dale, and Matthew Mize. Bowman opened with a word of prayer and Dawes led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Dawes requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged. He stated that if a member of the public wishes to address Council, he or she should raise their hand and state their name for the minutes.

The first order of business was to approve the minutes of the May 22, 2017 meeting. Dillon made a motion to approve the minutes. Curless seconded the motion and it passed by a 7-0 vote.

Sheriff Bob Land was present to request Council's approval of the Sheriff Department's contract with a new attorney. He explained that the attorney previously contracted for several years had recently passed away, so he would now like to contract with Attorney James Austin. Land explained that he had sent the contract to the State Board of Accounts (SBOA) in order to get approval to pay the \$4,000.00 contract out of the Sheriff's Commissary Fund. The SBOA had no issues with paying the contract from that fund. Dale made a motion to approve the attorney contract. Curless seconded the motion and it passed by a 7-0 vote.

The next order of business was to address the Additional Appropriation requests: Present for the requests were Health Board President Keith Walters, and Highway Director John Martin.

Explanation: Per John Martin, Highway Director: This appropriation is to fund the oil for 2017 Chip & Seal program. Martin explained that in the years past, this was funded by the Local Roads and Streets budget but due to revenue decreases, it has to be budgeted from the MVH funds. Explanation submitted by Circuit Court Judge McCallen: The transfer would assist with the cost of purchasing a laptop for the Judge's use away from the office. Dillon made a motion to approve the request for a transfer of funds. Mize seconded the motion and it passed by a 7-0 vote.

Presented to the Wabash County Council, read in full and adopted this 26th day of June, 2017 by the above aye and nay vote.

In attendance to speak about drainage concerns were Paula J. Papich 7628S SR 15, LaFontaine, Herb and Maxine Hughs 7725S 100E, LaFontaine and Deidre Earl 7670S SR 15, LaFontaine. Paula Papich stated that there is an overflow of water from farmland that flows over County Road 800 South into the residential area on State Road 15 every time there is much rain. She stated that basements are flooding and asked if more could be done to address the problem. Herb Hughs asked if the drainage tile had been inspected lately. Council Chairman Dawes stated that this is an issue for the County Drainage Board and then asked the Commissioners who were present and who are members of that board, if they would address the questions. Commissioner Barry Eppley stated that the Surveyor's office and the Drainage Board are aware of this problem and that they are working on a solution. Discussion continued between the concerned residents and Eppley after the meeting.

Chairman Dawes presented a proposal that a Commissioners' representative and three Council representatives meet with Larry DeBoer of Purdue University before the start of the official 2018 budget hearings in order to review budget requests and set funding priorities. He stated that no decisions would be made by the committee. He asked for three volunteers from Council and said that he would be willing to serve on the committee. Matt Dillon and Matthew Mize said that they will also serve.
