# WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, December 4, 2017 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Jeff Dawes called the meeting to order at 5:00 P.M. Seven Council members were present: Dawes, Randy Curless, Matthew Mize, Matt Dillon, Lorissa Sweet, Philip Dale, and Kyle Bowman. Bowman opened with a word of prayer and Dawes led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Dawes requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the October 23, 2017 Council meeting and the minutes of the Solid Waste budget hearing. Dillon made a motion to approve the minutes. Dale seconded the motion and it passed by a 6-0 vote with one abstention from Sweet who was absent from the Oct. 23rd meeting.

The next order of business was the transfer of funds requests. Present for these requests was Highway Superintendent John Martin. No one was present to represent the Circuit Court.

Explanation submitted by Sheriff Bob Land: These amounts make up the Community Corrections reimbursement of expenses because of sharing the building and the utilities with the Jail. These amounts have been deposited to the General Fund as a revenue, but now need to be additionally appropriated into the Jail budget.

Dale made a motion to approve the request. Curless seconded the motion and it passed by a 7-0 vote.

Sheriff Land supplied Council with inmate transfer figures for the year and reported that legislation for an increase to the inmate housing per diem to counties is pending at the State. He stated that this would probably increase the prisoner housing cost charged to Wabash County by other counties for the housing of our prisoners. He reported that two new jail officers have been hired and two new deputies are to be hired soon.

Explanation submitted by County Auditor Marcie Shepherd: We need the additional appropriation into the inmate accounts in order to get them out of the negative. Could not pay invoices from the LIT Public Safety Fund because the balance was not adequate since the distributions are deposited monthly.

The exam of records account does not have enough money remaining to pay the expense of the audit of the Town of Roann. This expense is reimbursable to the County from the December tax distribution to the local governmental units.

Commissioner Eppley reported that figures are being compiled for the purchase of an existing building or the construction of a building for the relocation of the County Health Department and the housing of the County Coroner's office.

Dillon made a motion to suspend the rules regarding the need for two readings of an ordinance and to vote on the ordinance after the 1<sup>st</sup> reading. Curless seconded the motion and it passed by a vote of 7-0. Dillon made a motion to approve the 2017 Amended Salary Ordinance as presented. Sweet seconded the motion and it passed by a 7-0 vote.

In regard to the amendment to the 2018 Salary Ordinance, Auditor Shepherd directed Council to the copy of the Personnel Administration Committee recommendations from the committee meeting on November 7th. She explained that the amended ordinance reflects the recommendations to the 2018 Salary Ordinance effective January 1, 2018. After questions from Council, County Coordinator Jim Dils explained that the Circuit & Superior Courts' Administrative Assistant, Court Reporters and Court Bailiffs would be receiving a 5.6% increase for 2018 as compared to the 1% increase for all other county

employees because of the request and explanation from Judge McCallen and Judge Springer and as recommended by the Committee. Commissioner Eppley stated that a comprehensive wage & salary analysis needs to be done prior to 2019 since it has been nine years since the original wage & salaries rating system was initiated. It was also noted that an additional appropriation request would need to be submitted to Council after January 1, 2018 in order to fund the additional money needed for the increases as listed in the 2018 amendment.
