WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, December 3, 2018 in the Commissioner's Meeting Room of the Wabash County Courthouse. Vice-Chairman Kyle Bowman called the meeting to order at 5:00 P.M. Five Council members were present: Bowman, Matt Mize, Barbara Pearson, Lorissa Sweet, and Philip Dale. Council members Randy Curless and Matt Dillon were absent. Sweet led in a word of prayer and Bowman led the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Vice-Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to review the minutes of the October 22, 2018 Council meeting. Dale made a motion to approve the minutes. Mize seconded the motion and it passed by a 4-0 vote with Pearson abstaining due to her absence from the October 22nd meeting.

The next order of business was to address the additional appropriation requests. Present for the requests were Sheriff Bob Land and Highway Superintendent John Martin. No one was present to represent the Solid Waste Management District.

Explanation submitted by County Auditor Marcie Shepherd: An amendment to the salary ordinance was signed in Dec. 2017 for these 2018 salaries but an additional appropriation was not created and approved for the funding in conjunction with the amendment. The transfers of funds will provide the additional salaried amounts that were approved by Council.

Mize made a motion to approve the request. Dale seconded the motion and it passed by a 5-0 vote.

This was presented to the Wabash County Council, read in full, and adopted on the 3rd day of December 2018 by the above aye and nay votes.

In the next order of business, County Sheriff Land updated Council on the latest jail statistics. He stated that the current average of the jail population is 101 per day with continued housing of inmates in Miami and Elkhart County jails. He said that Miami County is currently only accepting a few inmates at a time and Elkhart County is too far for transporting inmates that currently require court appearances. He stated that there should be enough money for inmate housing costs for the remainder of 2018. Council member Mize asked if there is corroboration between the Courts and the Sheriff's department regarding sentencing and inmate releases. Land stated that the Courts are utilizing Community Corrections and early release for non-major crimes as much as possible whenever appropriate. He stated that state legislation has been proposed to increase the inmate per diem from \$35.00 per day to \$45.00 which could help with housing costs. Since this was the last Council meeting that Land would attend as acting Sheriff, he thanked the Council for their cooperation and assistance during his years of county service. He stated that he would be assisting the newly-elected Sheriff with year-end reporting. On behalf of the County Council, Vice-Chairman Bowman thanked Sheriff Land for his years of service to

Wabash County and for his patience and perseverance with the continuing challenges of the inmate housing situation.

Since this was the last Council meeting for County Commissioner Scott Givens as a Commissioner, he thanked the Council for the cooperative relationship with the Commissioners. On behalf of the County Council, Vice Chairman Bowman thanked County Commissioner Givens for his years of service to Wabash County.

Next, Council member Mize suggested a possible change from the currently scheduled meeting time of 5:00 P.M. to 6:00 P.M. for 2019 Council meetings. Brief discussion followed with Vice-Chairman Bowman suggesting that the discussion continue at the January 7, 2019 organizational meeting since two Council members were not in attendance at today's meeting.
