October/November 2019 Auditor & Treasurer Financial Reports Wabash County Solid Waste Management District's Income Statement - Sept/October 2019; November's Statement was not available yet; they are making corrections and making sure the information is right.

Mr. Eppley gave a brief overview of the jail study, stating the committee met with USDA about possible funding for a new jail. The USDA offers a loan with the interest rate of 3% for 40 years, with no pre-payment penalty. There are numerous items that need to be completed to be eligible for a USDA loan. Eppley also informed Council that on December 12 anyone who would like to tour the new jail in Tipton was welcome.

Mark Wood, a driver for Wabash County Highway Department, spoke about the drivers' concerns dealing with the wage increases from the job study. Mr. Eppley gave a brief outline of the job study and advised that the committee did not have time to review the study in depth before the budget hearings. He stated the Personnel Administrative Committee will be meeting to look over the job study more closely. Ben Black asked for a copy of the job study that the wages was based on.

Roger Harber asked how raises were handled; Chairman Bowman said it is determined by the position, not the county as a whole. Mr. Bowman stated Council prefers to address increases during the budget hearings.

With no other business to come before the Council, Chairman Bowman adjourned the meeting. The next scheduled meeting of the Wabash County Council is Monday, January 2 at 6:00 P.M.
