The Wabash County Council met in session on Monday, April 20, 2020 the meeting was a joint meeting with in person/zoom. Chairman Kyle Bowman called the meeting to order at 6:00 p.m. three council members were present: Bowman, Barbara Pearson and Matt Dillon. Phil Dale, Matt Mize, Randy Curless and Lorissa Sweet all zoomed into the meeting. Dale joined the meeting after the meeting was in progress. The proceedings of the meeting were recorded by the County Auditor’s office.

The first order of business was to review the minutes from the March 16, 2020 Council meeting. Dillon made the motion to approve the minutes. Pearson seconded the motion. Votes were taken by roll call and it passed by a 5-0 vote. Sweet abstained and Dale was not present at this time.
