WABASH COUNTY COUNCIL MEETING

The Wabash County Council met in session on Monday, October 26, 2020 in the Commissioner's Meeting Room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Seven Council members were present: Bowman, Matthew Mize, Randy Curless, Matt Dillon, Lorissa Sweet, Philip Dale, and Barbara Pearson. Mize opened with a word of prayer and led in the Pledge of Allegiance. The proceedings of the meeting were recorded by the County Auditor's office.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was to approve the minutes of the September 21, 2020 Council meeting. Dillon made a motion to approve the minutes. Curless seconded the motion and it passed by a 6-0 vote. Sweet abstained from the vote.

Bill Hartley, Wabash County Prosecutor, requested adjustments to his 2021 budget. Hartley explained that two-thirds of his IV-D budget is reimbursed from the state and would like his Investigator and office manager to be at the same wage as others in the office with similar duties. Mize made a motion to adjust the salaries back to the PAC recommended amount of \$36,367.00 for budget line items 1000.11500.000.0008 & 1000.11304.000.0009 and amend the name of the position to show the added responsibilities. Sweet seconded; it passed with a vote of 7-0.

Cole Wyatt, County Highway Superintendent, requested adding three part-time employees to the workforce at the WCHD to be utilized during snow events to supplement the full-time employees. This is necessary in part due to the reduction of the department workforce that has already taken place. This request was previously approved by the commissioners in their October 26, 2020 meeting. Dale made a motion to approve three part-time new hires for a total of four part-time driver/operators, using money already in the budget to fund them. Mize seconded; it passed with a vote of 7-0.

Marcie Shepherd, Wabash County Auditor, requested permission to replace the accounts payable deputy that is retiring on December 11, 2020. The new person would start December 14, 2020 and the first check would come from the 2021 budget. This request was previously approved by the commissioners in their October 26, 2020 meeting. Mize made a motion to allow the replacement of the employee, Curless seconded; it passed with a vote of 7-0.

Auditor Shepherd informed the council that Ryan Burke with the DLGF said that it looks as though the county is under the max levy by about \$102,700. If the county would like, there is still time to re-adopt the budget before the November 2 deadline. In order to do this, the council must rescind the adopted budget, increase the operating balance by \$200,000 and reapprove the same budget. Mize made a motion to rescind Ordinance Number 2020-85-10 of the 2021 Approved Budget. Dillon seconded the motion; it passed by a 7-0 vote. Mize then made a motion to approve Ordinance 2020-85-15 for the 2021 Budget (as published in the September 21, 2020 minutes) and to increase the operating balance by \$200,000 to hit the max levy. Dale seconded; it passed by a 7-0 vote. Dillon made a motion to suspend the rules and move to a second reading; Curless seconded; it passed by a 7-0 vote. Dale made a motion to approve Ordinance 2020-85-15 for the 2021 Budget; Mize seconded; it passed by a 7-0 vote.

A public hearing was held to consider Ordinance 2020-85-13 modifying the Local Income Tax allocations by reducing certified shares by .01% and property tax relief by .01% while increasing Correctional Facility by .02% and changing the property tax relief allocations. After much discussion, Dale made a motion to approve the Ordinance as written, Curless seconded; it failed by a 2-5 vote.

The next order of business was the consideration and adoption of the 2021 Wabash County Salary Ordinance. Dillon made the motion to approve the 2021 Salary Ordinance. Pearson seconded the motion; it passed by a 7-0 vote. Dillion made the motion to suspend the rules and proceed to second reading Sweet seconded; it passed by a 7-0 vote. Dillon made the motion to approve the 2020 salary ordinance on second reading. Dale seconded the motion and it passed by a 7-0 vote.

On October 26, 2020, a public hearing was held to consider an ordinance (a) decreasing property tax relief rates from 0.50% to 0.40%, (b) decreasing the certified rate 0.1%. and (c) allocating 0.2% to the LIT Correctional Facility. Proper notice of the public hearing was provided pursuant to IC 5-3-1.

BE IT ORDAINED that effective January 1, 2021, the local income tax rate imposed within the County shall be modified as follows:
