WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, September 19, 2022 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Lorissa Sweet, Barbara Pearson, Matt Dillon, Philip Dale and Matthew Mize. Sam Hann was absent. Mize opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

The first order of business was review minutes of the 2023 Budget hearings. Dillon made a motion to approve the minutes and Dale seconded the motion; it passed by a 6-0 vote.

Next was a review and approval of the minutes of the August 18, 2022 meeting. Dillon made a motion to approve the minutes as presented. Dale seconded the motion; it passed by a 6-0 vote.

Shelly Baucco, for CASA, reported the receipt of the Federal VOCA grant. The two-year reimbursement grant is for \$157,645.60. CASA submitted a budget of \$70,919.00 for the first year. Dillon made a motion to approve the grant. Dale seconded the motion; it passed by a 6-0 vote.

Ryan Baker, Wabash County Sheriff, presented his Community Engagement Policy for council approval. Baker explained this was in response to the SBOA audit questions. Dale made a motion to approve the policy. Dillon seconded the motion; it passed by a 6-0 vote. Baker requested that Bowman sign the letter for extra pay during the trial. This was approved earlier in the year during the first trial, and when asked Baker said the overtime was not included in his budget.

Next on the agenda were the requests for additional appropriations.

County Sheriff Ryan Baker explained he did not anticipate the gas prices to be so high when he submitted the budget. Same with the food; he had cut his request for this year's budget but food prices have gone way up. Pearson asked what the policy is for take-home cars and could we trace the mileage to be sure it is not being abused. Tyler Guenin is to follow up on this. Dale made a motion to approve the request. Dillon seconded the motion; it passed by a 6-0 vote.

Sandy Beeks, Director of Central Dispatch, said she had not budgeted enough to cover the costs. Dillon made a motion to approve the request. Sweet seconded the motion; it passed by a 6-0 vote.

Mize asked if the council should go ahead and give the Courts the raises they've demanded. Mize reminded the council that the county attorney has said if the courts sue that the county may have to pay the attorney fees, so perhaps it would be cheaper to just give the amounts demanded. The difference in pay compared to other counties is not much; we pay the employee 3% of perf and require fewer work hours, thus making the pay almost the same.

Dillon, Pearson, Sweet, Dale and Bowman would like to wait for the mandate from the courts on principal, saying it is not right for the Judges to mandate some wages be higher than others in the county as it feels like the court is bullying the council into giving them special treatment which is not fair to the other departments that do not have the caveat. Council has given an unprecedented 8% increase and feels that should be enough.

Haupert said the demand has happened in the past. Dawes said he finds it absurd the position the council has been put in and does not agree with it.

Bowman asked if there were any other comments or questions on the budget. Hearing none, he reviewed the rates as listed below. Bowman said as he understands it the rate is .537 per \$100 of the assessed value on a property.

Dillon made a motion to approve the 2023 Budget as presented. Dale seconded the motion; it passed by a 6-0 vote.

Review information on Work Release. Bowman had sent out an email with information on work release. Mize said more financial information is needed to be able to make an informed decision on building a new building and the others agreed.

Council has requested the following:

- 1. Full Estimated Budget
- 2. Estimate of how much revenue it will bring
- 3. Cash flow profit and loss statement
- 4. The number of new employees needed
- 5. If the grant covers the new positions needed to run a new facility;
 If not, how much will be requested from the county to fund the program
- 6. The number of current prisoners that would qualify to be in the program
- 7. The number of successful graduates the program has had in the last 5 years and also the last 10 years
- 8. The number of the successful graduates that have been back in the program

Dale wants to know if we are putting a lot of the county's resources toward a small number of the population. We need to be able to pay the bills and be fiscally responsible to the county as a whole, not just a few. Bowman said that the judges would like to meet and talk over the different options for a work release center. He will request the information so they can have it ready at the meeting.

With no other business to come before the Council, Chairman Bowman adjourned the meeting. The next scheduled meeting of the Wabash County Council is Monday, October 17 at 6pm.
