WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, October 17, 2022 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Lorissa Sweet, Sam Hann, Matt Dillon, Philip Dale and Matthew Mize. Via Zoom: Barbara Pearson. Mize opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

Bowman took a minute to thank Lorissa Sweet for her service, awarded her a plaque, and invited everyone to stay and enjoy treats. Bowman said he appreciated Sweet's faithful service and the economy of words.

The first order of business was to review the minutes from September 19, 2022. Dillon made a motion to approve the minutes and Dale seconded the motion; it passed by a 7-0 roll call vote.

ORDER FROM JUDGES FOR MANDATE OF FUNDS

Discussions were held on the pending mandate to increase court employees' wages higher than the 8% approved in the 2023 budgets.

Bowman opened the floor after giving an overview of the council's decision to give an 8% raise to everyone. Bowman stated they had a meeting with the judges and were told to either go with the 12% they put in their budget request or be prepared for a mandate.

Dale stated he does not like the mandate and pointed out that the other counties included in the court's comparison were larger with a bigger tax base. Although he does not agree with the additional raise, he is not in favor of going to court over it.

Pearson is not in favor of increasing court wages and feels the court is "bullying" the council into paying them more. The council has been more than generous with raises and the court coming back with this mandate is misleading about how hard the other county employees work. It's more of an elitist thing that happens in Washington, not here in Wabash. She feels that we have agreed to look at the salaries again next year to help get them more pay. She is willing to stand on principal and say no to the judges at this time.

Pearson reminded everyone that per the court employee handbook, they have more personal days and vacation days than other county employees. Pearson stated that she feels they are stealing from the taxpayers. Although the judges are willing to sign a statement saying they will not do this again, there is no guarantee they will even be the judges in a few years, rendering any guarantee meaningless.

Mize understands that although 8% is less than the requested amount, we pay the 3% employee match for perf and only work a 7-hour day. The comparison with other counties' court staff was only looking at the wage and pay, not the total package. The mandate may cause a divide among county employees. Mize stated that although he would like to stand on principal, he feels we should go ahead and pay it, as it will be less expensive in the long run.

Hann pointed out that every department would like higher wages to retain and attract employees. We need to remember we are dealing with taxpayer money. We gave an 8% raise this year and if the courts are not happy with that increase, they will need to sue us for the larger amount. He is ready to stand on principal and say no to the judges at this time.

Sweet echoed the sentiment of everyone else before her, and feels it's a slap in the face to the other offices that do not have this ability to mandate additional wages. Council was very generous to give the 8% raise and she does not want a bigger divide between the buildings. Sweet stated we have completed a job study and have been working on wages to keep them competitive, but she also is willing to draw the line and say no to the judges at this time.

Dillon said he personally has been the liaison to the courts and has enjoyed it. He understands this was not going the way he had proposed things, but with some regret this is where we are. While the council should not micro-manage the departments, it is their job to do so. We are to set the budget and decide what employee's wages should be. He does not like this situation at all and it will cause a divide. He hopes we can do this in a way that is not combative, but he stands by the council's decision that has been made.

Bowman then opened it up to the audience for comments.

Judge McCallen said he thought a good conversation was had at the small meeting with the Council.

Mark Guenin, on behalf of the courts, said he is disappointed that council members who didn't make the meeting are speaking against the mandate. He said that the meeting was mandated and council did not show up. He said months of discussions have been made, the courts said this wage is what they need. The courts have lost 3 of 8 employees, 37% of the workforce, and no other office could continue to work as well as the courts have under these circumstances, especially with a job that takes training. This is not another department of the county; the courts are separate from the county, as the courts are part of the judicial branch of government. Saying you would have to do this for other departments is not correct; you set amounts for other departments because you are the legislative branch. Commissioners are the executive branch that sets policy. The judges are the judicial branch and they have tried to work with the council for months and the at the end of the day it is the judge's decision what they will pay their people. They are not another county department, period, wages for their employees are the courts' decision. Guenin said he will personally make three times as much money if the council votes no tonight. But at the end of the day the courts will make this decision, and that is what you can tell yourself now to vote yes. When this is all done, the County Council will have to pay the attorney bills on this suit and right now, we are at \$9,000 but if we go to court, it will be upwards of \$27,000 or more. He suggested Council is being penny wise and pound foolish for something that is not their decision but the courts', as judicial is a separate and equal branch of government. Further, if the mandate isn't agreed to tonight, he will instruct the court to ask for even more money, suggesting \$7,000 instead of \$5,000 and \$5,000 instead of \$4,000. They want to be competitive with what the city and fire department makes. There are things to go to war over but this \$13,000 amount is not it. Guenin thinks the council is wasting taxpayer money and time. The judges are not going to back down from this mandate; the courts are too important.

Brian Haupert said the council has been through this before and lost. Like it or not, the judges will win per the Indiana Code.

Guenin explained the process of the mandate--to have an executive meeting with Council and then to have a vote during a public meeting. If not approved tonight, it will be filed and a special judge appointed and it will be decided there. The procedure is rare but is set up to take care of this issue.

Bowman had high hopes that we would come to an agreement but no compromise was made, as has been done with other departments. Guenin reminded him that this is not a department. Bowman replied by asking why the courts have to submit a budget to council? Guenin said it was so Council can write the checks. They don't write checks over there; if they could, they would. The Auditor writes the checks for the commissioners and the courts. There is a clerk of the court that handles other duties for the courts, but that is a county position; they are not asking for more for the Clerk's department. The judges are separate and equal; although the funds come from the same place as the other departments, at the end of the day the courts make the decisions for the courts.

Mize reminded the council that the county attorney stated if the courts mandate, the county may have to pay all attorney fees, so perhaps it would be cheaper to just give the amounts demanded. The difference in pay compared to other counties is not much; we pay the employee 3% of perf and require fewer work hours, thus making the pay almost the same.

Dillon, Pearson, Sweet, Dale and Bowman would like to wait for the mandate from the courts on principal, saying it is not right for the Judges to mandate that some wages be higher than others in the county; it feels like the court is bullying the council into giving them special treatment which is not fair to the departments that do not have

the caveat. Council has given an unprecedented 8% increase and feels that should be enough.

Jeff Dawes stated he finds it absurd the position the council has been put in and does not agree with it.

Judge McCallen just wanted to let the council know that they have saved money where they can and do not want to be at odds with the council. The courts know the amounts they need to operate.

Mize made a motion to go ahead and give the Courts the raises they've demanded. Dale seconded the motion. Votes were Hann-no, Dale-yes, Dillon-no, Sweet-no, Bowman-yes, Pearson-no, Mize-yes; vote failed to pass 3/4.

WORK RELEASE

Mark Guenin and Jeff Hobson gave a presentation on Work Release and the benefits of the program. Guenin reported that a work release program should gain the county revenue annually. Work Release is a Sheriff's program; Community Corrections runs the current program. The new proposal is for a stand-alone work release program apart from the Sheriff.

Dale and Pearson asked for staff requirements and the fixed costs. Will the program be self-funded or will it require county funds to run? Can we get an estimate on the costs for a new building? Hobson said that he does not think the state will give any new staff funding more than is currently provided.

Next on the agenda:

Auditor Shepherd for EMA requested approval on the EMA Salary reimbursement grant for \$32,990 and the EMA Competitive reimbursement grant for TDMA compatible radios \$20,000. Dale made a motion to approve the grants. Hann seconded the motion; it passed by a 7-0 roll call vote.

Next on the agenda were the requests for additional appropriations.
