WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, December 11, 2023 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Matthew Mize, Sam Hann, Philip Dale, Gary Ridenour. Matt Dillon participated via Zoom. Nick Kopkey was absent. Bowman opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

First order of business was a review and approval of the minutes of the October 16, 2023 meeting. Dale made a motion to approve the minutes as presented. Ridenour seconded the motion; it passed by a 5-0-1 roll call vote; Hann abstained.

Resolution 2023-85-08 Declaratory Resolution approving Personal Property Tax Deduction for CFC. Auditor Shepherd reported this resolution is for the personal property Abatement that was approved in the October 16, 2023 meeting. Dale made a motion to approve the Resolution 2023-85-08. Mize seconded the motion; it passed by a 6-0 roll call vote.

Resolution 2023-85-09 Authorizing County office holders and/or employees to open accounts. This resolution is for Crossroads Bank to clarify who can open accounts and be on the bank accounts for the county. The bank requested this for audit purposes. Hann made a motion to approve the Resolution 2023-05-09 Authorizing County office holders to open accounts. Dale seconded the motion; it passed by a 6-0 roll call vote.

Resolution 2023-85-10 Authorizing a loan to Finance Reconstruction of the Leffel Drain #596. The Reconstruction loan with cost up to 237,000 will be assessed to the owners of the land to be paid over a five (5) year period. Dale made a motion to approve the Resolution. Ridenour seconded the motion; it passed by a 6-0 roll call vote.

Interlocal Agreement with North Manchester for Ambulance service in the north part of the county. Shepherd explained that after several meetings and discussions concerning the services the Commissioners approved the contract earlier in the day. Eppley reported they will be doing a study to see if the County could provide the services themselves at a lower cost. Hann made a motion to approve the 5-year agreement. Dale seconded the motion; it passed by a 5-0-1 (Mize) Abstained.

Geoff Schortgen, Purdue Extension Director gave the annual update on services in Wabash County and thanked Council for their support. Schortgen informed the Council that the state has added Keri Salb-Mertz, Community Wellness Coordinator for Wabash and Grant County. Salb-Mertz reported her roll will be working with community partners for a healthier community. Jessi Huston, 4-H Youth Development Educator outlined the progress of the program and reported that the fair will be July 16-21, 2024.

Keith Walters, EMA Director requested approval to apply for the Building Resilient Infrastructure and Communities Grant. This grant will fund the update to the Multi-Hazard Mitigation Plan (MHMP). Dale made a motion to approve the application. Ridenour seconded the motion; it passed by a 6-0 roll call vote.

Dr. David Roe, County Health Department along with Chris Straub, Diane Engel, Marcia Payne, Lori Foust came to discuss the current offices for the Health Department; new salaries and new responsibilities. Roe said the current office is not adequate and requested the status of getting them into an

appropriately accessible building. Roe went over some of the new requirements with the Health First Indiana funding. He stated they need more space to perform the duties required by the new funding. Barry Eppley, County Commissioner reported they are looking at the building the county has at 808 Manchester Ave for the Health Department along with other options.

Dr. Rickenbaugh said the State Health Commissioner visited last week and he is excited that the funding is coming to help improve the health in the County. He said that the Health Department needs help from the Council to reach the goals. The two points he took from the meeting was this is an investment that will continue to be funded, and this is a State wide effort that will help with the local programs.

Roe said he tried to get on the agenda with the PAC (Personal Administration Committee) because he feels due to the new responsibilities his employees need salary increases. Eppley expressed concern with a 50% increase in wages. Roe stated he is concerned he will lose employes if he doesn't get the salaries increased. Mize wants to see what all needs funded beside salaries. Mize and Bowman requested new job descriptions showing the added responsibilities to be able to warrant the salary increase.

Sheila Paul with the State Health Department, said they will help with setting the KPI (Key Performance Indicators) required with the Health First Indiana during the first year they. The County will be in control because they set the KPI's for our community. 2024 will be to get the KPI's set and getting the department set up to meet the requirements. The Department will need meet the indicators to continue to be in compliance. Paul said the State understands it could take a couple of years to get the service going to meet the indicators.

In wrapping up the discussion Bowman said during the organizational meeting next month he would schedule quarterly PAC meetings so they could review the salary and personal requests. Bowman said he would forward the e-mail he received from the Health Department to the rest of the Council to review. Bowman asked that the Commissioner's give an update on the status of a new Health Department space in the January Council meeting. Dawes said that Kerri Mattern has offered to assist with sorting the items that need to be accomplished. Cheryl Ross asked if we could lease a building? Ross said this was more of a comment than a question.

The next order of business was the consideration and adoption of Ordinance 2023-85-11 Amendment #1 to the Salary Ordinance 2022-85-10.
