## WABASH COUNTY COUNCIL ORGANIZATIONAL MEETING

The Wabash County Council met in session on Monday, January 8, 2024 in the Commissioner's Meeting Room of the Wabash County Courthouse. County Auditor Marcie Shepherd called the meeting to order at 5:00 p.m. since a new Council chairman had yet to be elected. Six council members were present: Kyle Bowman, Phil Dale, Matt Dillon, Sam Hann, Nick Kopkey and Matt Mize. Gary Ridenour was absent. The proceedings of the meeting were recorded by the County Auditor's office.

Shepherd asked for nominations for the 2024 Council Chairman. Dillon made the motion to nominate Kyle Bowman for Chairman. Dale seconded the motion. No other nominations were heard, Dillon made the motion to close the nominations and proceed to vote. Mize seconded the motion; it passed by a 6-0 vote. Auditor Shepherd turned the floor over to Chairman Bowman. Bowman asked for nominations for Vice-Chairman. Dillon nominated Matthew Mize as Vice-Chairman for 2024. Hann seconded the nomination. No other nominations were heard. Dillon made a motion to close the nominations and proceed to vote. Dale seconded the motion; it passed by a 6-0 vote.

Council reviewed the proposed 2024 schedule of meeting dates. Dale made the motion to approve the schedules as presented. Dillon seconded the motion; it passed by a 6-0 vote.
