NOTICE TO TAXPAYERS OF BUDGET ESTIMATES AND TAX LEVIES

Notice is hereby given the taxpayers of Wabash County, Indiana, that the County Council, of Wabash County, Indiana, at the Wabash County Courthouse, 1 West Hill Street, Wabash, Indiana, on **August 17th and 18th at 12:30 P.M. and Aug.19th, 2010 at 4:00 P.M.** will conduct a public hearing on the budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objecting petition with the proper officers of the political subdivision within seven days after the hearing. The objecting petition must identify the provisions of the budget, tax rate or tax levy that taxpayers object to. If a petition is filed, the political subdivision shall adopt with its budget a finding concerning the objections filed and the testimony presented. Following the aforementioned meeting, the fiscal body will meet at the Wabash County Courthouse 1 West Hill Street, Wabash, Indiana, on **September 13, 2010 at 5:00 P.M.** to adopt the following budget.
